  - 2) due to the cold, people are less likely to want to deal with medical care and come out of their shelters/tents into the cold or open their shelters to letting cold in
  - 3) less likely to go to the hospital because if they have to walk home they have to walk in the cold
  - 4) as camps are being raided and swept, street medics are less able to establish the personal relationships needed to do follow ups for on going medical care

- 00:42:37 Rob Huff MDC (he/him): We do the first two things because the third thing requires it.

Always, the plan will be driven by best-practices, and by the collected expertise of City of Tacoma and Pierce County staff. However, people with histories of homelessness or currently experiencing homelessness are key to every decision. We must ensure the unique needs of traditionally underserved populations especially people of color, the LGBTQ community, and people with disabilities are appropriately represented in the planning and decision-making processes.

- 01:10:56 Larry Seaquist: And to follow on Cynthia's excellent point: The "plan" submitted by the County with a CoC label was a disgrace a non-plan that is completely unusable.
- 01:10:56 Tina McLeod: Please note, (and please correct if I am missing it): the Coalition Role Expansion document shared does not use "race" or "equity" at all in the document. With known racial disparaties and other inequities in the housing systems, especially homelessness, proposing any new work and structures without truly working and embedding a racial equity will lead us to furthering whiteness and institutional racism.
- 01:13:13 Sally Perkins: If the Coalition intends to center racial equity, then racial equity needs to be prominent and insistent in the documents and the work. And it needs to be actionable, not just aspirational. Mr Pitchford is speaking truth. One challenge is to figure out how to maximize his experience and wisdom in ways that accommodate his schedule and his workload.

- 01:14:52 Larry Seaquist: Carolyn is making a key point. Planning is not possible without vastly better, real-time data and data analytics. We do not have that kind of data now.
- 01:15:23 Sheila Miraflor: To add to Carolyn's remark of women sleeping on the streets, I'm receiving phone calls from single women and Moms with small children sleeping in their vehicles.

There is a bill in the legislature, HB 1220, which if it passes will require the county and its cities to address housing more explicitly in the comprehensive plans. It will require the long-standing Housing Element to include "housing affordable to all economic segments of the population ..., promote a variety of residential densities and housing types, and encourage preservation of existing housing stock."
- If this bill is passed, it would mandate planning for units of moderate, low, very low, and extremely low-income households; and emergency housing, emergency shelters, and permanent supportive housing.
- Given how long-standing the need for affordable housing and the homelessness crisis have been going on, this is something that should have been happening already certainly at the county level. But since it has not, we could begin this planning process now. Even if HB 1220 does not pass, the need for this level of planning is essential.
