- 01:33:01 Jessica Grandon: Wrap around services need to include mobile supports, on site medical and dental teams, and they must meet people where they are. Services should be tailored to the community and the needs of the people. For some the initial intervention may need to be focused on establishing stability medically and in a mental health capacity before moving forward with the other key essential needs like housing. Balance between full service and case management teams on site as well as other sites that offer different levels of assistance.

- 01:34:03 Timothy Harris: Group 8 is unanimous on emphasizing immediate harm reduction by prioritizing low cost shelter that can more quickly be put up to serve more people. There was an idea about finding ways to bring services out to more low cost shelters. Maybe there is a way to be creative about this. On prioritizing services, the thought is that this should lean toward groups most excluded right now, such as felons and sex offenders. There was also discussion about how expectations that people will be able to increase their income to become more sustainably in housing are not realistic: a problem when programs for poor people are designed by those who no not understand the challenges of poverty.
