Rosemary Powers

Yes, good morning. I just am checking the sound on my machine. Does it sound alright. Okay, sounds good. I was just reflecting being here a little early. Any of you who came early this experience this morning was a little bit like what used to happen when we met in person, sort of all milling about sharing what's going on and and sharing announcements and things. So if you like that kind of experience, come early, of like five to or something like that and you'll you'll get a little conversation. That's great. Well this week is in preparation for the fact that we're not meeting next week because of the Thanksgiving holiday or because we decided because of the Thanksgiving holiday. And of course the idea is to think about what are we thankful for and sometimes that can become a little model and that we're thankful for all kinds of things in the midst of uncertain times. It's sometimes feel cynical to talk about being thankful. But I have to say that this network is worth being thankful for. And the work of all the folks who are putting their shoulder to the plow or putting their shoulder to the wheel and putting their hand to the plow, I guess is how that goes. And I do remember that, learning back about the origins of that phrase about shoulder to the plow that the carts with huge wheels, sometimes they were up to your shoulder height and those muddy roads that were in the 17th century were hard to push the carts over so often they got overturned and you had to push your shoulder there to get it back up. So as

we do this work of putting our hands to claws and shoulders to wheels and minds to zoom. It's worthwhile to step back at least a bit. Bit to be thankful for the people who are engaged in this work and in every which way, including that especially those who are living on the streets and trying to create communities of caring in the midst of the kind of trauma that they are experiencing. So with that, I'd like to, excuse me, mentioned our norms for anyone who's new and that we'll have a moment to introduce folks who are with us for the first time. We have developed as a few norms for zoom over the year. And the idea mostly is to mute ourselves. When we're not talking so that background noise doesn't interfere with others, and also turn off our videos if we're taking other calls or doing other things so we're not distracting. And then we encourage people to use the chat function as a way to communicate during the meeting in any kind of way. That's appropriate for that hearing background in sharing background information or networking information or more information about what you'd like to talk about in the meeting if there isn't time. So it's a really good source and it's not disrespectful at all. It's a way to make contact and keep ourselves going. And today I want to just read the community norms, mostly we pick out a couple of them to talk about and put them whole set in the chat. If you can do that, Rob, that would be great. So we've stated that we want to lead with an equity racial equity lens be aware of power dynamics, challenge concepts, not people listen to learn one person speaking at a time speaking from our own experience, making space and taking space, assume best intentions and take responsibility for impact. And be aware of time and agenda. And now those kind of float over here there but they're in the chat. And at the end of the meeting, Rob have always asked us to give our evaluation in some way of what we've done during the meeting. So it might be useful to look back at these near the end of the meeting and see have we done these how well are we done these and if you wish to share your thoughts about any of that, that's encouraged. So is that if you're new today, making maybe making a presentation or you haven't been here before? just unmute yourself and say hello, I'm so and so and I'm with whatever I'm with and then we can talk with you later about whatever's going on. So anybody can just unmute yourself and do that.

Hello, my name is Andrea Hogue. I'm the corresponding Secretary with the South End Neighborhood Council and I'm here today to see what you guys are all about. I also am part of a grassroots group 253 Merrymakers, and we go out and do a little bit of street outreach. So thanks for having me.

Thanks for being here. Andrea. That's great.

Hi, my name is Danny Goodrich. I work for the Department of Social and Health Services at the Public Assistance Office on my team, and I'm not new I get your guys's notes and pop in every once in a while but I do have some updates. That I'll be sharing

Thank you Daniel welcome. Joe, are you about ready to speak? I see you're unmuted.

Hello, my name is Joe Purva. I work for the low income housing Institute and I currently operating the company that will be opening up here shortly.

Rosemary Powers

Welcome we're very happy to see you. Thank you Well, thanks to the new folks and if any of you are returning from being here away for a while and want to check in with people just use the chat as a way to make those kinds of context. So Rob, back to you.

Rob Huff

Thank you, rosemary and welcome everybody. One more little reminder before we get into our first standing section of the meeting this week, is please do use the chat to continue sharing information throughout the meeting. We retain the chat. So if you want to share information and ensure that we that it will be seen by others that's a great place to put information throughout our meeting this morning. So let's shift to our regular standing item reports on what's happening on the streets this week. We use this section of the meeting to ask people who are doing regular street outreach to share what needs they're seeing changing on the street. Anything that others in the group would be useful for them to know and what specific needs are out there. So I open the floor is just an open invitation for folks who do street outreach to share what they're seeing this week. And you can just raise your hand or I see Jeffrey has done just that. So Jeffrey, want to start with you.

Jeffrey Boyce

Good morning everyone. One of the things that I'm starting is 10 Count, add encampments throughout the city. And maybe the county. I don't know if I can handle that much but at least through the city. If in your outreach, you could just do it 10 count and then email me and let me know what that is. I'll see if I can keep a running list going. I know somebody else was working on some names of people in camps, but right now it's just how many 10s do we have out there? Thank you

Thank you, Jeffrey Monique.

Monique Brown

Yes, good morning, everybody. Um, so Wednesday, the in cabin and five which is a huge encampment. tents and cars and RVs. So much confusion out there. They were told they had to leave. One One veteran, a woman veterans that she was given an hour to leave. The group up front said they weren't told to leave at all group in the middle said they had been given 72 hours. Just a whole bunch of

confusion out there. People were just taken off. And I think by now probably most of them are gone. I'm going to go out and do another check. But it was not done the correct way. And just a whole bunch of confusion. We said people to save parking in different areas but not a whole lot to send them to. But that's what's happening now out there and five

So it was just it just caused a whole bunch of confusion people were in a panic some left some did not. It yes just a mess right now but five PD were the first persons the first organization that said you got to leave.

Okay. Do you know if there was a notice posted at all?

Monique Brown

No, but one gentleman I didn't see any notices. But one gentleman said when the notices posted you got to listen to that. So there must have been something somewhere at some point because he was moving because of a notice. I didn't see any anywhere.

Okay. All right, Teresa, you have your hand up.

Theresa Power-Drutis

So I was going to ask if anybody knew it was up with five so thank you Monique for bringing that but I also also wanted to say that I know the rise Center has been doing a tent count for a while so Geoffrey you might want to plug into them instead of starting an alternate. Thanks.

Thanks, Teresa. Wolf, your hand is up Yeah,

so serve the people that are regular distributions. This week. We were at camps a few different times to deliver food and mattresses and bed frames and warm clothes. Etc. Other than that we have started serving at the G Street encampment as one of our main locations ever since evergreen got swept and needs are still the same. It's really cold out there. People need warm stuff. We're trying to get out as

Thank you. Well, Maureen. You're muted right now.

Maureen Howard

Yeah, I know. It doesn't work. I mean, it works to keep me quiet. But anyway, forget to unmute it. So folks, that just because I don't have a title doesn't mean that I've gone away if you run into an encampment, please shoot me an email, send me a text right away. And I'll backchannel that as fast as I can to try and find out as much as I can. And I'll also shoot you a list of just reminders of things to attend to. So thanks.

Rob Huff

Thanks, Maureen. And I think I think many of us are well aware you haven't gone away well, if I see your hand is still up, did you just leave it up? Or do you have something to add?

Wolf

My bad? No, I'm good. Okay.

Rob Huff

And I see you're able to respond to Mark's question in the chat. So thank you for that, um, anyone else with things that they would like to share? From what they're seeing on the streets this week? Andrea, did you want to say something? Yeah.

Um, well, just recently I had good news. I have two of my neighbor's homeless neighbors that are ones going into treatment. And one is going into housing and so I'm, I confirm that one of them went into housing because he just kind of disappeared and that always breaks my heart when I'm used to going around and seeing certain people but, um, so there's a lot of joy there. And a lot of as of recent, I give out condoms and some of my outreach bags and there seems to be a bigger need than when I've been able to fill for condoms. So just something to keep in mind if you don't already have those in your kits. Thank you.

Thank you. Anyone else with final items for this week on the streets? Jeffrey, I see your hand up again.

That's great news. Yeah, and we'd love hearing those. Those positive resolutions if folks have them. Anyone else with items from what they've seen? On the streets this week? Okay, I'll only let the awkward silence go so far. So thank you, everyone. And one reminder is if you since we are not going to hold the meeting next Friday. Please do use the mailing list. If you encounter things and needs during this week, folks are still around. We're just not holding a meeting next Friday. So I don't want to leave people hanging, if at all possible. So let's shift to our first presentation of the day and I'd like to invite Timothy Harris to give us an update while we congratulate him for the launch of the dignity dignity city website, the News Tribune article that came out we'd love to hear what you're doing now and how things are going and how we can support

Timothy Harris

Absolutely, you can all hear me right? We can. Great. So I'm just so excited that this thing is getting off the ground now and so grateful for the support that we've gotten from the coalition and folks like Marine who agreed to write a regular column for the paper. And our focus right now is on building community support for the project and preparing to launch the physical paper distribution of a physical paper and March. This morning, I want to just really quickly go over what the street paper concept is how dignity city works, and how people can help us get this thing off the ground. The street paper concept really simple idea many of you are familiar with the real change paper in Seattle. It's all about creating low barrier opportunity, while reducing the isolation and stigma of homelessness. It's about relationships. street papers are a medium for creating supportive healing relationships across class, getting people to care, care about each other, getting people to talk to each other who otherwise probably wouldn't be doing that. The mission is to harness the power of caring community to offer opportunities for self help to those in need. Pretty straightforward. The way dignity city is going to work is like all street papers. It's a low barrier, employment opportunity. No ID is required. People go to an orientation they agree to a common sense code of conduct. They get a badge and their first 10 papers free after orientation and after that they get their papers at cost up front sell them for \$2 plus tips. Keep everything they make a lot of flexibility for people to work when and where they like. We do our best to set them up for success. Um, our launch is in Tacoma here but the vision is to grow and to a statewide paper and an advocacy tool that is viable in multiple small communities across the state. It's all about bringing that kind of engagement that we were able to create in Seattle with real change and taking that to smaller communities you know, places that otherwise would never have a street paper. Our advocacy agenda is really going to take our lead from our key allies will be supporting the advocacy priorities of the coalition taking our statewide cues from the Housing Alliance and at the same time being open and respectful of a variety of perspectives. Right now, our board is very Seattle centric. It's people that I've known for my career homeless folks that were involved in as being vendors and really successful at that. You can look at our website to see what our board looks like. Right now. We're going to be filling

that out over the next three to six months with folks from this community as well. So if there are people who are concerned about that, want you to know that that is on the agenda. In terms of how people can help. I'm just going to drop something into the chat window right now. Wait a minute. Holy cow. Yeah. You know, it's pretty basic. I want to get to know you all. Our whole model is about building community relationships, figuring out how we can support each other's work. You know, dignity city in particular is particularly relationship driven. As we work here and to come and we expand to other communities. We want to be working closely with agencies that are working with homeless folks in the community. And that takes conversation that takes getting to know each other it's a big priority. I want to talk to focus and figure out who else I should be talking to. So please get in touch with me and I will likely be reaching out to you. Dignity city and street papers in general are very much built on grassroots community support. I encourage you to support the project yourself. Every gift is a show of community support.

It's just really important to start building that now. Because that's what's going to make this sustainable over the long term. And finally, sign up for updates. Stay engaged with the project. We're going to be keeping the community informed as we're moving this thing along. And just to close, you know, I encourage you to visit the website. Now. The news blog is already up. It'll give you a taste of sorts of articles that we're interested in publishing. We're also really looking at supporting and engaging the local arts community here. I think that that will be a powerful mix for the publication way of bringing people people in and really kind of filling a niche that is there. Um, so broadly speaking, we're always looking for story ideas, community contributors, want to hear from you about things that you think we ought to be paying attention to. And with that, I think we've still got a little bit of time left for questions.

Rob Huff

We do, Timothy. Thank you. So Mike, you have hand up?

Monique Brown

Yes. Hi, Timothy.

Timothy Harris

So emanate. Hi, I

went to an event in Seattle, where you were speaking and I loved the event. I love what you had to say. However, I just missed what you were saying earlier because I was looking for the article. So in the article I was quoted regarding my concerns about folks having to purchase the paper first. Sure, and it and then so and I missed it. I heard you right at the tail end. I said, Oh my God, he's answering my question. So could you go back to that and tell me about the purchasing of the paper, please?

Yeah, absolutely. You know, that's a big part of our model is that the vendors do pay basically cost for the paper up front. It's really about building investment. And it's about self respect. I mean, our whole model is that this is a hand up not a handout. When people pay for a fraction of the paper up front and keep what they make when they sell it. Um, that means that it's less a charity thing and more you know, you're an independent small business owner, you're an entrepreneur, you're buying your product. Up front, basically wholesale and selling it retail on the street and people take pride in that huge part of the street paper model. It's pretty much how they all operate.

Monique Brown

Where are people selling these papers I know in Seattle, I was up there and they're all over the place on the street. But down here, I don't see the same kind of downtown and

be a challenge. It's gonna be a challenge because not only do we have the sort of decentralized nature of Tacoma and really kind of a lot of car culture going on here. But we've got the solicitation code, which is fairly radically anti free speech. It's probably the thing that I am most concerned about, and the launch of this project so it's going to be about finding places where vendors can be successful. being really clear about that and also getting permission for vendors to be able to sell on private property. Which is again goes back to the importance of the community relationship building. You know, and finding places like churches, farmers markets, places where you know, groups of people come that would be interested in supporting a project like this and building relationships with them. And over time, I think it's going to be about pushing back on that solicitation code. I mean, there is a long list of places people and things that you can't be within 15 feet of and that's gonna be a problem.

Monique Brown

And is your team going to be the ones looking for these places so you can give suggestions to the vendors on where they can sell?

Absolutely, I mean, a big part of our work is setting the vendors up for success as much as we possibly can and and you know, that that means part of that is scouting for turf. My experience is that the vendors themselves are probably the best people for finding places that they can sell the paper and be successful. They're pretty good at pioneering that. But you know, it's it's a mutual endeavor, and we try to find those places as well and have places where we can send people and they can be successful.

And then my very last question, sorry, Teresa. No, you had a question. Very last question. And I was doing a whole bunch of work in King County You guys created a wonderful resource book. Will you be doing that down here in Pierce County?

I love the Emerald City Guide we stole that idea from the Portland Paper Street routes the Rose City Guide I would love to create a guide like that for the Pierce County area. Um, it will be our first priority. But I think that that's something that we'll definitely want to work up to.

Okay, thank you. Absolutely. Thank

Teresa, you have your hand up and then there's a question the chat is ultimately.

Theresa Power-Drutis

So i i Monica asked almost everything that was on my mind, but I wanted to ask this one other thing, which is to Monique's issue about people in in Destiny and somebody may not get back. Do you have any system where someone could buy a gift certificate for five bucks so that money could give it to somebody who wants to try out so on the paper and they could see how it goes? Something like that?

Timothy Harris

Yeah. Just sound like that. Yeah.

Theresa Power-Drutis

I know. There are ways

that we can do that. I do want to stress that when somebody signs up to sell the paper, we give them their first 10 copies for free, so that they can see whether this is something that works for them without making any investment up front. And the other piece is that you know, well real change sells the paper to the vendors for 60 cents and they sell it for \$2 and we'll probably get to that price point. For the vendors after a while. Initially we're going to be selling the paper to the vendors for 30 cents each because it's going to be more important for the project to get the paper out there and get vendors involved and lower the barriers. To that, then it's going to be important for us to to have the revenue of the paper sales coming in. We're really about building the the kind of reach of the paper and doing everything we can to support that.

Theresa Power-Drutis

You have solved everything you are this is a wonderful way.

And I see a question about basically self employment tax. The answer to that question is yes, I mean, up to the point that people are making \$6,000 a year, which won't be that many of the vendors they don't really need to worry about that. But part of the orientation is that we tell the vendors that they're responsible for their own tax liability. And you know, at that time of the year we like help vendors, you know, with whatever they need to be able to do that. The majority of vendors aren't concerned about that, but we do help the vendors that applies to

Josh Castle

I rob Thank you, everyone. I happen to be drinking out of my real change mug, by the way. Point that up there. I'm so just so honored to be speaking right after Tim Harris and yeah, that's Tim Harris is the founder of Real change and in 1994 and this is a really exciting launch of dignity city. So thanks for doing that. I just found it so funny. I was I was drinking I drink out of his mug all the time. So I want to know that. So good to see you. So let's see. So we have Joe curve on and Chi Gianna Campbell. I think she was with us a moment ago. But she might have had to jump off for a meeting or they're having a management meeting right now. And Joe is going to share some updates on how things are going at Comfort Inn. We have an exciting community meeting coming up on Monday and a couple of things going on through that we're forming the Community Advisory Committee, and then I have him and I also have updates about our Tim site DICOM emergency micro shelters. And we can share any

updates we have about our six and orchard site as well. So Joe, I'm going to hand it to you. Thank you, Josh. Thank you.

I will go ahead and start with just some of the stats for our our attempts for site which is the most recent one we opened up on 69th and proctor. Since October six we have had 11 positive move outs. You know so it's really starting off really well. Serving, serving over seven people. Since we opened. I know that the six an orchard is doing extremely well. That site has 44 positive move outs serving close to 130 people since they've opened so that's amazing. You know, so I'm super excited. About this company and project which we are projecting opening late November, early December. So as long as everything continues to go in the positive momentum direction has been going we foresee that that's not going to be an issue at all. As Josh mentioned, we do have the meeting coming up for that on Monday Darren pan is gonna be the point of contact for as far as getting information to to attend that. I think that we also will be forming the CAC for the confident as well so you know everybody's invited for that. We can drop my email in the chat for that as well so we can make sure that if anyone is want to be involved in that they can as well. I believe those are the biggest burden matters for the comfort in and we're projecting for the company and for the Tim Sykes.

Um so we can put in the contact information for Darrin right now is emailing him as the way you get the information. So we're working closely with safestreets on this to to you know, running the meeting together and they're they're really like on the ground, helping, you know, helping out there, along with Joe in our in our Lehigh staff. So we're working closely with them. And so that's you know, that's going to be opening up to serve. How many people is it again, just

projection so there's there's 90 rooms 12 will be specifically retained for liquid and then we the restrooms will be from coming from Tacoma our main referral agency is going to be the homeless outreach team. But we will be working with other agencies as well like Urban League come rescue mission next chapter, CCS so on and so forth. And we are max capacity we're looking at as 120 So that's kind of our projected numbers right now for the 90 rooms that we

have. And Lehigh owns the site. And we're planning on converting it into permanent affordable housing over time. So right now we're going to use it as a as an enhanced shelter. So I know we're really you know, we're looking forward to that to transitioning to that. So we are you know, like like we said we are forming a Community Advisory Committee on that if anybody knows somebody who was like in the in the area, it could be you live there you work there you have a business there you go, you know, there's you're at a school they're sort of a nonprofit close by, you attend to a faith community there you know,

you're somehow involved in the community, you would be considered a neighborhood stakeholder and you would absolutely qualify to serve on the CAC so just reach out I'm going to put my drop my email in the in the chat um, so just reach out to me and I can send along an application. So again, that meeting that community meeting is on the 22nd this Monday at 6:30pm. And then the other thing, just some quick updates on Tim's Stanford coma emergency micro shelters. We are you know, we opened we the expanded site added another What 20 houses I believe, and and now we've, we've added 11 People of exit into permanent housing since it opened just back in was it with when was that Joe was that was that I wasn't on October 6, I believe. And it opens it pulled that started accepting clients

on 69th Proctor's Yeah, yes, yes. Yes, it is. October 6 is when we started separate clients. We began to transition sooner on the 16th of the month prior, but that was moving the, the the smaller site and transitioning into the larger site. But we have these

we have these amazing case managers, we have three case managers working there who are working with all the residents and helping them with attaining you know, housing, employment Health Care Act, you know, applying for Social Security, getting their IDs and documentation because a lot of times people are referred that don't have that. And you know, so we're helping, you're helping the clients there with all those, all those anything that's needed to treat everybody as an individual on their individual journey, but we're very excited that 11 People have transitioned into permanent housing from that site. So we're just going to continue working you know, working away at that. And then we have our you know, we of course have our six an orchard site that serves this one serves, actually some families with children. So we continue to work partner with with the church there at that site. And then we are also partnering with the Puyallup Tribe at the, at our site at our village there so and then we're still in the process, by the way of, you know, we have the Lincoln district site coming up, that's coming up next year. That's going to be 75, units for seniors who were you know, who are experiencing homelessness will no longer be homeless when they're when they're in the building, of course. And then, and then the Phase two would be 2023. That would be 72 more units for people experiencing homelessness. So yeah, just really excited for these projects. Coming up and let us know if we can answer any questions. We're always available. I'm going to put my contact information in the chat. Oh, and by the way, I should mention the Tim's Community Advisory Committee just met this last Monday. incredible group of people. Very just a wonderful meeting and and a lot of just community champions and neighbors and businesses and providers in the area. So if anyone is interested in you know, you're you're close to that six nights and proctor site again, you have some stake, you know, in that community in that neighborhood, or even if you just and by the way these are public meetings, so anybody can attend if you want to attend all of them. You can you don't have to be on the you don't have to be a member of the committee to attend these meetings. And even if you're in the neighborhood, but you can't commit the hour and a half a month to attend the monthly meeting. You

So just a couple there are some questions about the who's the direct contact to access services. So a couple of folks wanting to know the referral process and who they should reach out to and then that's in the chat. So if you can answer that Josh in the chat, that would be great. Some of some of the positive move outs have been to family some has been to like kW, a they had a program and I apologize that's more case management so sometimes because I work operations I'm sometimes I get more of the information. You know, then sometimes how you know the process that the case managers navigating through but I do know that they work to come into kW a we also had some some vouchers, there was the Senate through the and I apologize them again, it's case management. A lot of the case management that would be a really good question for case management and, and because I don't remember all the acronyms and all the processes that they got them through. I'm sorry.

Monique Brown

Okay. No, that's okay. Thank you. And Joe, can you do me a favor and drop your email in the chat again, I wanted to speak to you before about this new encampment and I don't know what happened to email. So if you could drop that in for me out. Appreciate it. Thank you. Josh,

I just dropped mine in just in case if anyone's interested in joining the, you know the CAC or coming to that community meeting. Darrin we're working with Aaron pen with shade streets on the community meeting but I put all this work, you know, I'll pass it along. To him, and then we'll get that information to you. Okay,

I'm still still breaking down the coffee. Okay. So, yes, the referral question, Joe art is I actually I'm going to ask Joe if he would if he wouldn't mind speaking on that.

Depending on the site that you're going to and again the site I'm dropping my email in the channel so if we have more in depth but depending on the site, you're going to if you're going to six an orchard they work with six different fro agencies next chapter recovery Cafe Urban League, the homes outreach team first Christian and then if you're looking at like the Tim site, or main referring to there is a homeless outreach team. And that was going to be the same. I'll look here for the Comfort Inn as well. But all sites will still work with like see March, Congress, commission, Urban League and so on, but we are just the 69 and the Comfort Inn, our main referral agency will be the homeless outreach team. And when I put my email in there, I can give you contact information for these specific individuals. So you'll be able to contact him directly. And we can make sure that we can we can get individuals into the villages or the shelter

and I saw Andrea's question about including the South End Neighborhood Council and any communications regarding the Comfort Inn. So absolutely. We will do that. And by the way, we have three members of the south south and neighborhood council on the Thames CAC so we were well represented there. And so we you know, they can send out information on Tim says as well and you know, shared that at the meetings and we we attend those meetings and share out information as well. So we'll Yes, we will pass along the information. We have communications around the comfort end for sure.

Rob Huff

All right. Thank you, Josh. And it looks like if Joe can drop his email contact in there that should take care of some of those other questions that were out there. Really appreciate the update and hope folks can attend Monday's meeting. Let's shift on in our agenda. I wanted to turn the floor over to Maureen Howard for an update regarding the status of some work with the lived experience coalition.

Maureen Howard

Thank you and I'm glad to see we're right on time like every Friday. I love it. Okay, so one of the things coalition signed off on formally was a participation in the voices that matter project with the lived experience coalition that come up here, it's County Chapter, along with workforce, it's a speaker's bureau so the third partner in there and the lived experience coalition. Jonathan Hemphill was going we had asked him to come. Last night he reached out and asked if I would just update because I'd been on the Wednesday night partnership meeting and so I'm happy to do that. The lived experience coalition does have the contract now and it's going through the signing process. It's a finalized contract. And the

way that this is still the intent is that the speaker's bureau member Amanda walkingstick some of you know or have heard her speak. So the combination of the program that the speaker's bureau has put into place for people with lived experience in order to gain leadership communication skills, is going to inform and collaborate with the program that the lived experience coalition already follows in terms of developing leadership and helping people with lived experience be able to take their places use their voices on various boards and committees across the county and people will be paid there will be a \$20 an hour stipend for their work on these boards and committees. They will also have their transportation reimbursed or paid forward, I forget which and they will have whatever is required for them to have access. So if they need a hotspot or they need a Chromebook or that sort of thing. So this is pretty exciting. This combination of workforce and the lived experience Coalition and the Coalition to End Homelessness. Our the our contributions have been today to have been in addition to Garrett helping Lamont green from the lived experience coalition actually write the proposal have been to Garrett and I have participated in this steering committee that has met every other week. And Garrett is still defining his role. He loves this project, and he's trying to figure out how to stay with it. But his county job with county money is what he has to sort out with the county. So I've been hit, stepping in along with him and sometimes for him on this. I've asked the group who they would like from the coalition to represent the coalition. They've asked for Rob huff and Dan Peterson at this point. And so that conversation will go forward itself. A lot of things went on hold while they were waiting for the actual contract now that the contract is in hand. Things are moving forward. So the so where we left it Wednesday? Oh, I know the other things that we have done so we had we our coalition had received a \$5,000 donation towards the speaker's bureau at a time when I think Garrett envisioned that we would actually have the speaker's bureau is one of our programs and that's not the case. So we are transferring that money to the lived experience Coalition for this project. So we're making that investment we have offered from the beginning on access to whatever communication we have, please use the listsery, please ask for time in meetings. We've invited folks to participate in various ways. So there's that and I think the lived experience coalition uses a very intentional collaborative model. So sometimes things take a little longer, but when they are finalized, that everybody has bought in and everybody's voice has been heard. So just because it, you know, takes longer just means that folks who work more linearly have to be a little patient. The other things trying to see if there's anything else. I think that's that's really pretty much it. And just as a side note, having listened to how important that Lehigh conversation was for everybody. I honestly don't know what to do with the number of other things that I think are important to somebody but No, maybe not everybody. So the thing, so I'm going to try and put them on a one pager and send out but please, if you work or live in the city of Tacoma, the no camping ban has now been heard by the community vitality and safety committee, and we show up in the official presentation as the advocates draft alright, you haven't seen the advocates draft because it was never finalized. We never signed off on it. In our working group with the mayor, the deputy mayor, Councilmember Tom's and the city attorney. The process was stopped because the city asked us to stop because they got the matrix report on police reform. And so I will circulate that draft now, since it's already shown up. And I the deputy mayor last night and I did bring to chair Aashka and Councilmember Hinds attention that in fact it was not the advocates draft. It was the collective draft of the city council people and ourselves.

We never brought it to the coalition because we didn't have a final but if you were here during those weeks that we met we reported almost every Friday on what the status was what the key issues were. There is now a staff draft, which I believe is NCS and they have re criminalized they plan the ordinance. So there are many things that are this might move fast. And CMS says they can have a final by November 9, which is the last meeting of CBS before the end of the year. If so, we are going to have to figure out a way to respond. So that's and so I will there'll be a separate watch for a separate email just on this ordinance. All right. The other things if you work in 34th and Pacific, please let me know. All right, that encampment, and folks, FEMA is funding hotel rooms at 100% through April or until the first of April or maybe through I forget, but we have had zero response from the city or county on May taking advantage of that. So it took over say folks, if you're on this call, you've got a different voice. Take it forward and see if you can get those folks you've got their attention. We could immediately clear these encampments with hotel rooms that would be 100% reimbursed. We have a mobile home park in Puyallup where 44 families about 150 people have eviction notices. So there are a number of moving pieces out here. So thanks I took I know I took to my trump I'm sorry, screwed the agenda.

build back better passed the House this morning. \$150 billion for housing 6200 New vouchers for Washington State. All right. This sucker has to get through the Senate.

Yeah, now the sausage gets made. Thank you, Maureen. And I'm actually glad you squeezed in the update from the committee meeting last night. Maureen and I were chatting back and forth a little bit throughout that meeting and and appreciate that. Um, let's shift over to a quick update and announcement from Michael Yoder from associated ministries.

Mike Yoder

Good morning, everyone. We'll try to make this brief. Hopefully you've been getting wind up some news that we officially announced back on November 4, we've been sending out press releases that to come a weekly is running a large article this week about our news which has some implications for the affordable housing homeless continuum in our community, which is the merger of two local nonprofits that have been longtime participants in in the system. So you all need to know about this and then hopefully, we'll be encouraged by our plans to move forward so shared housing services under the leadership of their board and Director Mark Merrill have decided that their best way forward to to continue they're really valuable. And you know, I think innovative home sharing model is not to stay independent. And I think this is a very innovative, unique way to think but actually think the best way to to ramp up the idea of home sharing was to find an affinity organization to connect with that kid nurture

and perhaps even expand and energize the idea of home sharing. So they approached us some time ago and we've done a lot of legal wrangling with due diligence type stuff, and we are going to proceed in the weeks ahead to merge and then the so the idea of home sharing adult home sharing and our youth host home programs that have shared housing will be official programs. Embedded within associated ministries, the shared housing staff will come and be a part of associated ministries. And the reason that that works well is they have a relatively lean team over at at shared housing, and we already have a couple of community outreach coordinators who do community outreach for all of our other programs now well, they're out in the community, recruiting volunteers for other programs, they can also potentially talk about and recruit people to be host homes. So it's, it's that kind of synergy for why a program like shared housing can be more than the sum of its parts by merging in with am So Marc Merrill, the director at shared housing is going to come over and work with us at am to kind of keep the the to be the carrier the bearer of the torch for the shared housing model and help us with the transition of the programming and funder relationships that actually help us go out and look for even new sources of funding from maybe some of our funders that am who will be excited to invest in this idea. Folks, home sharing is an immediate solution. It provides very low income housing, just a few \$100 a month to rent a room in homes that is really one of the only permanent housing options for people the very low end of the income spectrum, and there are hundreds if not 1000s of empty rooms that could be sources of permanent housing available right now today in this community if we just had the bandwidth to get out there and recruit and make some of those homeowners aware of this opportunity. And it particularly works for certain homeowners who need to monetize their empty rooms, perhaps a senior who's having a hard time staying in their home and could take someone in that could provide a win win low cost housing for someone who needs that and stability for the homeowner. So we really believe this is something we need to scale up and we can you know, hopefully, house many, many more people through this new partnership and I don't know, just out of courtesy, if Mark was on the call to has just anything quick. He wants to say at least you should say I concur with am is not this is not a hostile takeover. Or he's in stunned silence.

Rob Huff

I think he's on a phone call. But he could be

totally concur, excited. And yeah, I think I think we can double I think we can go out and double the number of people we can help so

Mike Yoder

Oh, that's yeah, that's it's gonna be huge. I agree. Mark. Let's do it.

All right. Thank you for that update. I see a couple of questions. We can do them real quick, Jan

Janet Runbeck

You dub Tacoma in early fall late summer put out a notice that they were partnering with shared housing. Are Are those programs continuing? Do you have college? They are okay.

Mike Yoder

Yeah. But yeah, that's the kind of innovative thinking they've been doing over shared housing that we want to take and expand so they have this Husky Husky program where the university's reaching out to their alumni and saying, you know, would you be willing to take in a homeless current Husky student, and I think that's a beautiful way to help get the word of a word out about homes right so looking for affinity groups and going to them and saying would you take on someone that you have an affinity with so alumni associations, etc are logical?

Rob Huff

Right, and there's a question from Sarah in the chat for you Michael. And then Theresa has her hand.

Theresa Power-Drutis

So first, I want to say that Mark and his team have done a lot with a little over the years and I'm so impressed with what they got done. So that's for them. But also to say that I've been a thorn in Mark side in some way about people with criminal histories and I intend to be a thorn in your side, too, just to note give you notice.

Mike Yoder

Thank you appreciate the notice thorns always welcome that's how we can probably get better and change. And yeah, well, we'll be working on you know the evolution of the referrals for this program right now. Just keep calling shared housing and eventually the phone will ring am when you called shared housing, their adult home sharing program is is nearly all privately funded right now. And so there's a lot of latitude about how you can get into that program. And so we'll be working on in we're a little bit more publicly funded. So hopefully we can continue that private funding and have this particular program have a little bit more of a wide, wide entry portal than just through the normal referral systems.

Rob Huff

Okay, thank you, Michael. And I see Chipata with her hand up.

ChiQuata Elder

Thank you. Um, this is exciting news. And is even more exciting because the city of Tacoma is trying to put some structure around like shared housing to help people and to help it not be a barrier. And it's funny because like, the first time they announced it in this meeting, Mark emailed me and he's like, no, wait, hold on, what are you trying to do? And so once I explained to him, that we weren't trying to

eliminate it, and we just wanted to make it to where it wasn't a barrier people weren't being taken advantage of and things like that. He was all on board. So he's on my city of Tacoma stakeholder group. And so I think that this will be great with the two nonprofits coming together for him to really have that voice on what that structure around that looks like in Mark keeps me on task. So if you haven't experienced that yet, you're in for it because Mark will be on you to do to do so.

Mike Yoder

So great. I'm so thrilled to hear of your interest in supporting this channel and we really think that there's something amazing we can do with some support from the city.

Rob Huff

Great. So thank you, Michael, for the announcement. And folks have other questions that they want to ask in the chat. And I'm sure we Michael can get to those. Let's do our one other walk on item. I wanted to briefly give the floor to Danielle from she mentioned earlier that she had some news to share about a resumption of in person services. So Danielle,

yes, good morning. So the DHHS Community Service Offices public assistance offices reopened on Monday. We are open to limited in person services. And that includes picking up EBT cards tended to without an appointment they can come in previously we were only serving those with a general delivery mailing address so anyone can come in. Interviews, applications, all of that is still being done over the phone. So we do have six phone lines in our lobby. And I know with the homeless population, not having a place to go to use the phone has been a big barrier. So unfortunately we're not doing in person interviews at this point. So if someone comes into a pipe or services we are going to put them on a phone. It's out of the elements and you know, dry our wait times reached four hours yesterday. And on average, they're about two hours. So I know there's also the limit with you know, cell phone minutes and that sort of thing. But they can come in we can they can still apply online fill out a paper application but ultimately that interview has to be done. And if they're when they're calling in. There's no need to do those other applications because they do electronic signatures with the client so there's no passing of, of paperwork needed. We do attempt to get all information verified while we've got the client on the phone. There is a callback for some it's called sure connect I believe. But it's got its cues. Its maximum two so once those hit No no others are allowed. My suggestion as early in the day as possible we had someone come in at eight o'clock I had him on the phone at 805 and they had about a 1520 minute wait, but they were able to get in get services and they left with their EBT card. Other things that we can do when they just come in without an appointment. We are still doing identified a debit card ID vouchers for Department of Licensing. I did want to clarify on that. There was some confusion with the ID vouchers. That's the \$5 where they can pay \$5 It does nothing as far as a driver's license. If someone has a driver's license and they get one of these ID vouchers that will then cancel the driver's license. So it's really it's just the ID voucher piece. Um, for those families who are applying

for TANF right now, there are no there's the 16 month limit where people were being terminated. That is being waived right now because of COVID. So if you've had families you're working with that have been you know, closed or denied for the time limit extension. There is no time limit extension at this point. I think it's through June. I'd have to to verify that. But and those families we are trying to reengage for work first to try to get them into you know job search schooling training. So they are actively working with local social workers and case managers. Let's see. Questions. Oh, other things that they can come in and get if they've got if they need letters, or they've submitted copies of social security cards are copies of IDs to us previously. They can come in anytime between eight and five and we will print those out for them. They can drop off paperwork at any time. I think those are the biggies.

Rob Huff

Well thank you. Thank you for emailing me this morning to let let me know you had a few moments to stop in and give an update. And And if folks have other questions, I can definitely drop them in the chat.

And I I do have another meeting at 1030 I'm going to have to leave but I'll put my cell phone or my office number and my email feel free to reach out to me either way. If you've got case specifics and you've got the client with you, I can I can talk, you know, talk that out. For the EBT cards it's 10 to two phones are open from 8234 New applications and eligibility reviews and eight to four for just general changes.

Rob Huff

Okay, and I see Teresa has her hand up

Theresa Power-Drutis

just this that this has been pretty devastating. The office is being closed for people coming out of incarceration. And I want to just suggest that you give some thought to ways you could reach into the institutions if you're going to be so difficult to get an appointment with out here. I get the problem but I don't think people really understand how hard that is to come out with nothing right?

Rob Huff

Absolutely. Thank you. All right. So thank you again, Danielle. And look forward to seeing you in a meeting in the future as well. So our agenda has been blown out of the water this morning. So I'm going to shift things around a little bit with everybody. So I appreciate everybody's patience. We typically do our government updates around 10 o'clock. And so I would like to honor that and then we will shift our conversation about Thanksgiving resources to the second hour of the meeting. So with that being said, let's first see if we have anybody from the city of Tacoma on today's call with updates all right, I was not made aware of somebody was going to be here so that doesn't surprise me. Do we

I can't see. You know, I didn't see him earlier.

Valeri Knight

So um, yeah, I've actually been on the call for a few minutes. I was presenting with the Washington State House of Representatives this morning. Spent such a busy week. So I'm Valerie Pierce County Human Services pronoun she her hers. Thanks for having me again today. Quick update on rental assistance. We are currently at 88.85% spent for our Department of Treasury funds. We are actually putting in a request today for about 40 million more dollars of Treasury. They have anywhere from a couple 100 million to over a billion dollars of unspent Treasury dollars to be reallocated. So we're throwing our hat in the rink for about 40 million of those dollars. And then for the trap, which is Washington State Department of Commerce where 84% spent on that for 36 million, and our American rescue plan funds were already at 26% at 2.4 million of those. We've also already received our allocation of American rescue plan funds round two and our trap 2.0 So our amazing nine local nonprofits who I just cannot think enough, every single moment of my life are just doing amazing, amazing work. I am in the community a ton. Yesterday, we actually hosted an event at Tacoma Housing Authority shallow Shan and we had over 100 people. When we finally stopped counting, we stayed an extra hour and a half and then we zipped on over to South Hill Library where we served 15 more households and then today we're at five and and then Monday we're in villains, parkland and then Tuesday or silicom. And we are at the Pew all of tribe on Tuesday afternoon. So lots of opportunities to be in the community all of our information and our in person options, as well as our local nonprofit to do have some walk in options are available on our website on the calendar, which is new and improved. Kalea did a great job. We're also coming out with a paper application, we will have be able to send that out to folks if they're having any issues getting to an event they will be able to just pop it back in the knowledge to us and we will do all the data entry for them. So just really coming up with some super cool and creative ways to get folks to apply for rental assistance along with applying for new money. We were at Spokane Tuesday. When I landed I also booked my like got to register for my flight home. So that tells you how quick it was. But we presented at the Washington State County leaders conference on Wednesday afternoon. So that was great opportunity to really talk to some other counties about what's working and not working. And we always view every opportunity to speak as an opportunity to learn and listen so that we can continuously improve our process while we share the amazing work that's been done in Pierce County as well. So I'm happy to say I'll be around for a while before I head over to wherever I'm going next.

Thank you for your leadership, Valerie and for being here. So I know Jenny is on break right now but I it it's gonna be LEAH I think doing an update from Tacoma Pierce County Health Department.

Leah Ford

Yes. Hi, good morning everyone. My name is Leah Ford. I use she her pronouns and I support our community engagement team for our COVID response. And I typically attend these meetings but providing this update in Jenny's absence, and she will be out. Well, she'll be back in the office on November 29. And so yesterday, our 14 day case rate per 100,000 was 346 or hospitalization rate is currently 11.1 per 100,000. And we confirm 236 cases as well as six new deaths. We have updated our data dashboard on our website, just put a link to that in the chat. Definitely check that out. As far as Ing updates. We have 17 beds available. The lighthouse is closed as of the 15th and so they are continuing to add more capacity with we have two adult family homes that are pending, but they have agreed to be low barrier sites. And then again, as I'm sure you all are aware, the care coordination for those facilities is being handled by ERISA though. If you have any feedback or questions under this new system, just reach out to Jenny or myself and I'll also put my email and the chat. And All righty. So as of Monday, there were no outbreaks no active COVID outbreaks that we are aware of, and we did testing Shiloh baptist had no issues No, no positive tests, everyone is negative. We have a number of clinics scheduled for the remainder of this month as well as into December at shelters and these centers with vaccines being provided. By our contractor ambulance and really starting to see bigger numbers of people getting vaccinated at these events, which is very heartening. And we're also working on similar encampment outreach efforts. Greater lakes continues they're working encampment in camp. mense and going through the month of November and so just looking how we can can continue to support that. The MRC Medical Reserve Corps is providing flu vaccine at several sites as well. And we are really busy rolling out pediatric vaccines right now and we're just working to really be sure that our contractor is able to offer pediatric vaccines at shelters where they are needed. And the CDC is actually meeting today and likely booster doses for all folks 18 And up are new that should be available this weekend. But as of now, if you had Pfizer Maderna more than six months ago and are in certain high risk groups, you're eligible for that booster. You had j&j More than two months ago you are eligible. And additionally, people may get a mixed series booster dose meaning their booster dose does not need to match their initial vaccine series. So that's all I have for y'all today. I'll put some additional links in the chat. And if anyone has any questions, let me know. Thanks.

Not a question as much as a resource. It was just recently announced that there were more than 100,000 deaths last year due to fentanyl overdose. The health department and the lower level has free Narcan. Narcan works. Now in the case of fentanyl, it probably is gonna take more than one one shot of the nasal spray but the it is free. It's in the basement of the health department every morning that that the clinic is opened down there if folks want want some Narcan and it's hard for it to send staff, let me know and I will deliver it to your shelter or to your encampment. If you're an outreach worker, I will deliver it to you your team lead and then then have it on site and it's and instructions on how to use our with the Narcan kit. So it is a they made it really easy to use. So let's, let's think about prevention, especially prevention of death. Now. I'm all for that.

Jim, thank you for that and I'll just add really quickly to anyone who has insurance, um, you can get that for free from a pharmacy so typically when I'm in just like grabbing something I just asked for that. And so that's another thing for y'all to just be mindful of when you're out and about. Just grab it when you can because it's there. Thank you.

Rob Huff

That is great advice. Monique.

Monique Brown

Is that clinic located on Pacific? Is that what yeah,

3629 South East Street and it is on the Pacific side of the building. Thank you.

Rob Huff

Thank you um, so our last government update would be what do we have anybody from Pierce County Department of Emergency Management on the call today? I don't see anybody but I see Jan with her hand up.

Janet Runbeck

Raging Creel is with de m and she is going to be at our Monday zoom. The safe sites for all meeting register on our website here. Come Monday at noon and Regina Creel will talk about platforms for PC warn you anybody anybody in Pierce County can sign up for one of two or both platforms to be notified of pending disasters or warnings or whatever. The My big question to her is, if folks are already on the street what are they going to do about safety from a from an impending disaster so being notified as well anyway, that'll be a discussion for for Monday, de m raging Creel see you there.

Um, I was actually volunteered by fearless leader Kelly to take on this, this task and I enjoy. I enjoy digging for resources as Maureen can attest with what we did with the the COVID-19 Resource List last year. But I'm ok. Waiting for Rob.

Rob Huff

Sorry. Yeah, sorry. I am pasting it into a document so that I can share my screen just a second. Yep. You would think I'd be better organized.

Sheila Miraflor

Anyway, um, while he's doing that, I have the opportunity to reach out to some other county, county agencies and organizations. There we go. There we go. There we go. That's kind of the the very, very rough draft of that. And how do you address those needs. Rob Huff

all right. Welcome back, everyone. I'm sure that I hope the conversation was good. I'm sure that that was a very short amount of time. But I did want to get back to the main room so that we could share in the chat, anything that additional that you thought would be good to share from your meeting, or for your breakout meetings. And to get back to the last items that we have on our agenda for today's meeting. So in the interest of doing the ladder and moving along with the agenda. We have a few minutes set aside for Maureen to give us an update on where things are at with the Pierce County comprehensive plan to end homelessness and the steering committee meeting. That is coming up this afternoon.

Maureen Howard

All right, well, thank you and Garritan so you can chime in if he wants to add something in. But we do have the we have had the draft the first draft of the full comprehensive plan to end homelessness. I know that several people have responded to Garrett as he requested and provided comments. I've only seen a couple of people's comments. The steering committee will meet today from one to four and our consultant Bree Williams, with the technical assistance collective I think it is anyway, just one out to everybody saying please organize our thoughts and be prepared to try and limit our discussions on each of the goals that have been presented that kind of thing. As you can imagine, everybody wants to say everything they've already submitted to Garrett and maybe twice or three times. So it's going to be an an art of form meeting orchestrating all of the players who represent very different points of view in many cases, except that everybody wants to end homelessness, which is good. And this wraps up and by November 30. There will be a final plan and it goes to the Pierce County Human Services Committee meeting on December 7. So we are on a fast timeline now. The if you did not see the garret provided to me I just haven't gotten it out. I will get out the the PDF and the final shelter for all plan which was presented to Pierce County Human Services Committee on the 16th earlier this week, so you see what that final look like in terms of the of the plan and presentation. I think for me, representing the coalition, the points remain, whether this is an expansion of an existing system and a services plan or if this is what I have been asking for which is a radical plan to end homelessness which means we

treat housing seriously. And we restructure the existing system of shelters and outreach around build for zero. And we have we have we aggressively increase the permanent housing options that are available. I did a conversation earlier today with Mike Yoder and Mark Merrill about that particular intervention is an example of how to do it. We either bring down the cost of permanent housing for people or we get deed restrictions on the housing itself for people who are in that zero to 30% and 30 to 50%. Those two categories. We make certain that all of the systems that exist that support people, irrespective of their incomes, are available and accessible to people who are experiencing homelessness. And the providers who work with them. And we create some kind of I don't know what this looks like, of a coordinating function, a leadership function. Whether this function also takes on funding but it has to be sustainable. It has to be something everybody buys into, and it has to somehow be accountable so that we are always moving towards ending homelessness, that functional zero point and I we all know it's hard. All right, we all know it's an extraordinary ask. And so, all I can say is you are welcome to attend the meeting. There is a public link and there is also also there are continuing opportunities you all know how to get ahold of Garrett and to provide information. You all know how to get ahold of me. So that's that's where we are and we will, you know, this has a fixed and for this part of the process. What happens next? I think we don't exactly know. And one option is that the council says we we want you to go back to the ROG boards, and we want you to expand this part or we are pleased with what you have. And this is how we're going to take it forward. I think we we don't know that. Yet. But but the work has been people have really been serious about it. And that's been good. So Garrett, you can add anything in there, or Mike moisture if you're still on, or anybody else's on the steering committee. Who's on and I just don't see you.

Gerrit Nyland

I guess I could just emphasizing that. You know, this is a recommendation from a committee to county council and how that's received. And what happens because of that. And if we can get this in front of other municipalities and get them to kind of buy into it. One of the big goals is trying to create a central I can't remember what we're calling it how unified I gotta find what that is anyway. But basically unified homeless authority that would be accountable to basically what marine just described is always a weird line between homeless crisis response and permanent housing stability type things that doesn't exist in everybody's mind, but does exist in the bureaucratic structure and governments. So things like that, but really the, the, the the process and the timeline are producing something and how that gets implemented is, is still something that that we're going to have to be pushing on as government employees as activists as providers.

Maureen Howard

And I see Richard Burke hammers on he's on the steering committee. Richard, do you want to add anything? Courtney's on Courtney, you want to add anything?

No, I think you guys covered it. Agreed.

it's just a reminder that we've got dem representative on Monday, but is Paula Anderson. Do you see Paula Anderson is she here? She was here up all I take away is give us an update.

Paula Anderson

So a Jan graciously applied to greater Tacoma Community Foundation because the county is giving us an amount of money to hold that program steady at four locations for the rest of the year so that we can continue to pay the costs associated with that for each site. Things like sanitation costs, garbage, porta potties, things of that nature. And, and greater community. Tacoma Community House may be working with us to provide a bridge loan, which they don't normally do, but we're in the process of negotiating that. They're not really doing that anymore, but we'll see what happens on that. Because the cash flow of course, with the money that we're getting from the county, that could be a little bit of an issue for us, depending on how that goes. Because we will have to expend a amount of money by the end of the year. And so that means putting out big chunks of money very quickly on this project, but I think I think we're good. I think we've developed a way to do this. That is streamline into assure that the people are the sites that are still working right now that are part of the program right now. And the people that are in them are still going to be able to have a safe place to park and that's the goal of what we're doing right now. So yeah, and the information the new referral line for guests and for service providers, is listed on the website, the county website or the safe parking almost Yes, that's what it is. Sorry. Just a couple of quick met mentions. I have agreed to convened two groups. One is called governance work group and the other is the Race and Equity Committee and just a brief update for governance. We are working right now with working together to confirm our mission as a coalition. Over the last two years we've developed in very many ways and become a real force within the community that we want to be able to sustain as an all volunteer organization we have struggles that have to do with sustainability and also ensuring that we have broad representation. So the governance group is working on this and we are a smaller group. So if anyone has that kind of interest either in your past or currently, we will be meeting this coming Tuesday at nine o'clock. The information will be on the PC homeless web page for you to come. If you want to just sit in and share your thoughts or join us that would be great. For the Race and Equity Committee. I just wanted to share one thing well first, we are meeting December 2 At three o'clock in the in the afternoon. That's a Thursday. So if that will also be on the PC homeless page. And just to mention one thing, we have a variety of recommendations we're looking at, but one of the things we'd like to consider at these meetings is that we all think about at the end of the meeting during that time when we have time for reflection and all is not only how well have we done at the meeting, but who should be here who would profit from being here with us and then we would profit from them being with us that we might invite to participate in various kinds of ways, groups that were associated with that have no particular organized relationship to the homelessness question but who may indeed be providing all kinds of services because they are human beings that recognize that the income unconscionable and immoral truck crisis that we're we're dealing with. So we're we'll be making some proposals to the steering committee next week. But I just wanted to put that out there for now as something to encourage us to identify groups that we can then invite to, to join us and share what they're doing and perhaps help them to see some things we might be able to do together.

Yes, good morning. On the 21st of December, we will have a memorial for homeless people that have died in this year. This is part and will be part of the national program. We've decided since the last one was in kind of a monsoon that the 21st of December it would be good if it was indoors. And the pastor at Shiloh Baptist Church has been kind enough to allow us to use their building so it will be it's a Tuesday at seven o'clock and working with Mike Yoder to get this all together. We hope to have all of the names of the homeless that have died for the whole year. More. We're working on that and we would encourage all of you to join us in during that service. Mike, do you have anything that you want to add?

Now but put that data in your calendar? I think, I don't believe maybe somebody under coalition here. Those don't believe it to come as ever actually had an official event that we've contributed to that National Day of Remembrance. So we're planning to register it with a national movement and make this an official Tacoma Pierce County event for the National Dave of homeless remembrance. They'll there's dozens or hundreds of vigils and services all over the country on that day. And of course, the significance of that day is the first day of winter which is the time when we need to be remembering of those who are unsheltered and those who have, you know, are likely to be super vulnerable as the winter months approach on that first day of winter. It's a good time to remember the loss from the past year so it'd be lovely for our community to see a good turnout of that event just to show our community how many people how many of us really care that these folks not be remembered. Yeah, I just wanted to make mention that in and so I guess add if you could put if you haven't already, could you put your email in the chat so I can have that we just had one of our homeless who was struck by a vehicle about three weeks ago. He passed away. What's interesting about this case and this is something I just it gives me hope for the city of pure wallet just to be completely frank because of all the you know, the hype and the negativity that seems to come from a lot of the community regarding homelessness. This gentleman who just passed away actually was not allowed at New Hope because of a background item. But he had been homeless in the city of Pugh all up and he started getting well known by business owners in the area and I guess he would help clean up and do different things. Many of our guests knew who he was. And I know that he was had had some developmental delays and and so it's it's interesting because I'm getting calls from business owners and community members about whether or not there's going to be some sort of celebration of life for this gentleman, and they're coming together and they're starting to put it together and I just I think it's fantastic that the community the business community is coming around this one individual that they got a chance to know and the reason they got to know that know him, I think was because he was not coming to New help and being served at New Hope where we could have you know, potentially done some other things. So I don't want to I don't want people to be upset with new hope about that because we do have guidelines that were very much what do I want? To say is sanctioned by the city as far as who we serve? Let's put it that way. And so that's where the dichotomy comes in. And I just think it's interesting and it gives me hope that maybe some attitudes are changing with with people that haven't done that. So I thought I'd share that as a Thanksgiving blessing to people.
