00:21:04 - Richard Dorsett: - This is what I posted as my Down and Out in Tacoma yesterday (February 17, 2022). I write because it helps me remember what I see, it slows me down to reflect, and otherwise, the days would run together.

As far as I am concerned, the sweep of the homeless encampment under the 705 freeway is a failure of our civic imagination and I ethically object to how it has been cleared of the people living there. Outreach workers, police, and cleanup crews are respectful of homeless campers and are not responsible for the decision to remove this encampment. No, that's going to fall on our city manager and her staff—bowing, it seems, to pressure to do something—and to our mayor and city council who have stood by while more than a hundred people were moved out of their encampment. Seven days notice to pack it up and move on. Nobody went into shelter.
