Stop these damned sweeps! Stop them now.

We can debate how to end homelessness. What is not up for debate are the cruelty and inhumanity of the sweeps of homelessness encampments. Every time this happens, the homeless ask, "Where am I supposed to go." If you sit by while this trauma occurs on our city's streets, if you offer no alternative, shame on you.

- What happened to do no harm? Move them, creating more trauma increasing likelihood of increasing drug use.
- Relationship between healthcare and homeless 48 years life expectancy for homeless individual.

  Thoughts if I were in their place, I would be getting high too. Housing first people deserve housing!

Harm reduction/motivation interviewing – takes time to build trust with people. Homeless dogs are housed and fed!

Don't go in talking first – feed them, clothe them, try to house them first before talking about substance use. You have to give people what they need first before you can talk to them.

Need to see more permanent housing – not just shelter.

Need to share stories and get better at crafting messages so as to better control the narrative. Also get better at enlisting support of broader community to help. Stability is required to address addiction. Addiction is just piece if the "cascade of problems" people are dealing with. Our work is to put people in the position of entertaining the choices that they have. Really listening is at the core of effectively helping.
- 01:52:06 Clinton Brink: We have a societal expectation that homeless people engage in self-improvement and quit drugs cold turkey. It's not a reasonable expectation. These people are concerned about getting enough food and water, staying safe, shelter, etc.
- An ounce of prevention is worth a pound of cure. It seems like most resources go to trying to help those who are already addicted. We're perhaps not focusing enough on prevention. If we provide people with more opportunities, more education, and more support in the first place, they may never resort to drugs or experience mental health issues in the first place. Lack of support is, perhaps the root cause of both homelessness and drug abuse.
