Rosemary Powers

Let me just get myself set up here. So welcome, everybody, to our open table where we take time every week to learn about efforts to respond to homelessness in Pierce County and renew our commitment to actions promoting safe and secure housing for everyone. We gather on the homelands of the Puyallup Tribe of Indians. Who have stewarded this coastal home for 1000s of years and call ourselves to listen to and uplift the voices and experiences of the indigenous people of this land and beyond. Today, it's really cold and we know people making home outside do not have the minimal support they need to make it safely through the freezing days and nights so we gather blankets and serve soup become overjoyed at finding an excellent large tent or scoring some hot water bottles or hand warmers. We welcome to donation of 1000s of bombas socks collect coats and towels and toiletries. And host free food markets and hot dinners. Some of us share our living spaces, others work to make the spaces match. We are navigators, mentors, counselors, healers and peers. We are people who know that not to take action is just another kind of action and so we do what we have to do whatever the negative voices say. Sometimes in the comments in the online Tacoma News Tribune

that follow a sympathetic story about the challenges faced by those living in encampments, or in other precarious situations. I see angry readers charged with some derision that such mitigating actions as we do, just encourage people to be freeloaders, and as evidence of ultimately ineffective and soft good doers and do gooder ism. But surely simply dismissing the catastrophe is not a realistic assessment of the state of our community. The suffering rings out as tents and other structures recently swept from one location are erected on yet another street corner or freeway underpass. As Mary Oliver says in a poem about reading of the horror of war in the morning paper, quote, what dark part of my soul shivers you don't want to know more about this and then you don't know anything unless you do. Somehow, for some reason, those of us gathered here have decided at least for now, that those some part of our soul shivers we cannot look away from the suffering of our neighbors, small actions, loud critiques, and patients that persistent lobbying and negotiating all fit in there somewhere, a bucket brigade and creative array of responses to this unrelenting humanitarian crisis. Today I leave you with Mary Oliver's thoughts on not looking away in her poem, the journey. She says, One day you finally knew what you had to do and began though the voices around you kept shouting or bad advice. The whole house began to tremble and you felt the old tug at your ankles, man to my life. Each voice cried but you didn't stop. You knew what you had to do, though the wind pride with its stiff fingers at the very foundations and though their melancholy was terrible. It was already late enough and a wild night and the road full of fallen branches and stones. But little by little as you left their voice behind the stars began to burn through the sheets. of clouds. And there was a new voice, which you slowly recognized as your own. That kept you company as you strode deeper and deeper into the world, determined to do the only thing you could do, determined to save the only life you could save. So welcome to our conversation as we begin the month of December and it's cold and challenging times. For those of you who are new, I just really remind you of our norms for an activity together here is to keep ourselves muted when we're not talking to use the Zooms hand raise function, if you want to say something to limit distractions by turning off your camera if you need to take another call or do something else. We encourage you to use the chat as a space for announcements, networking, asking a follow up questions, sharing ideas about what has been presented. That might not have time for live conversation. We save this and it's available after the meeting, and you can save it yourself as well. We also have community norms for our conversation, but I'll say today that our basic one is that we respect one another try to make time for one another and pay attention to the most vulnerable among us. So that we're not taking up too much space with ideas we think are so important to us. So with that, I'd like to welcome those of you who are are new or who've been away for some time to let yourself be known to say your name and perhaps something a little about your just to mention your organization. This is not a time for longer introductions, if you represent a group that might be willing to share your story with us. We have that as a possibility and you can let us know in the chat that that's something you'd be up for doing. So someone who's new would like to begin that and Rob or I can recognize you.

there's also been some some rumors going around that we had electricity and that we melted down some electrical box. Let me clear that up right now. We don't have electricity. We did not melt down any box. We have one box and that's for the office trade and we use that for the kitchen so I'm not sure where all these things are getting out. But we still got guys over there cold. And ladies. Yeah.

One more question for you Are there? Do you guys have hand warmers that are able to be used by folks there so you at least have something like that?

We have the hand warmers, we have body warmers. We have wool blankets. And that's pretty much what we're using hot water bottles were mentioned to us as well. So the some of those were delivered yesterday. Thank you marine for that. And thank you all for helping. It's been amazing. But yeah, that we've been using a lot of hand warmers and body warmers and wool blankets. It's got where we're at Yeah.

No, just more of the same. We've been. I was out with Teresa with the food. Somebody gave us a 10 person dome tent yesterday that we got out over to the post office site and just more of the same blankets, hand warmers and checking on people so we'll be out

great, thank you Richard. And Luis, I know you're on the call any updates you can give on how things are going at the 35th am Pacific site.

Luis Rivera Zayas

Ah yes. We have a delay on on delivery of like our office trailer on the overhead shelters. Were there. We got the team that we have working there but we also got a team from downtown going there checking on everyone and making sure that everybody's okay. Also sustaining snow removal or if anything that that needs to happen there. We are at capacity. So we already got every every time is filled. And I will continue to update as things get in place.

Rob Huff

Thank you, Luis. And I know there was some confusion earlier in the week about whether whether folks at the gate there were accepting donations from the community and any of that kind of thing. Do you have any guidance on that?

Luis Rivera Zayas

The guidance needs to coordinate through CRM just like everything in any other campus. That way we don't have seven people showing the same day. I will make it more specific in our websites where we maybe just do a separate one for donations, but everything goes through the normal

process. Okay, the normal process is going and taking things to the donation center.

Because we go okay, go specific needs and then we can actually take that to them directly rather than have a whole bunch of stuff that we don't need there and don't have what we really need.

We have? We have tarps the same the very same day that I was identified. We had tarps over them before the famous press release came out and we have that is temporary until we get the big overhead shelterlogic tight over them that are no I'm windproof

That'll be nice. Yeah. Well, one of the things that I looked at is that Auburn wants actually the wind gets inside of one. So that might be an issue. This one's actually our wind and snow. Rain rated, so we will not have that issue. One of the things that we are doing is every going out every 30 minutes, and making sure that there is no buildup of snow on the tarps because the weight could affect the tents. So we took that step because we understand until we get that we will have to be very vigilant about that.

Yeah, this weather is hell on tents. So good luck with all of that.

Yeah, and I'll second to thank you for being here. This morning Luis. Real quick Bob anything you can offer updates from the peninsula how're things going for folks out there

we thank you to Jessica Hall. She came out Wednesday actually met with two homeless gentlemen. Yeah, it was it's wonderful when TRM can't come out. Totally understandable. Jessica pittstown. She's, as well now working on two other referrals that came out of that visit. Jay Jay found some clothing and wet sleeping bags up on point Fosdick just out up across the street from Panera. We the individual was gone but apparently had been visited by the fire department and earlier in the day. I took up some clothing Jade, got it all arranged for them up there and we hoped they would come back but we haven't seen them. The clothings gotten the new stuffs gone so we hope they're they're off and running. We've talked offered sorbets now deputy sheriff of Pierce County who he and his group patrol the KP he's on board and he's calling us if he's finding anybody that's in trouble and keeping us updated as they reach out there as well as the fire department. But we don't have any regular outreach. You know, they day in day out on the KP so we'll get there.

Thank you for what you're able to do out there, Bob. And I'm sure the folks folks out there who are currently without good shelter are very thankful. And let's see, I didn't notice Do we have anybody from East Pierce County could kind of give us a little bit of an update of what's being seen out there. Hi,

Paula Anderson

Hi, Rob. Yeah, so we're seeing more people at nouveau because we've been opening our doors at 8am and keeping it open until four 430 ish. Having people come in and get warm, giving them lots of meals, hot food. And then today is a Friday normally we are closed on the weekends. So on these days, we prepare extra lunches that they can then take with them. We did go out and distribute handwarmer

socks food, drinks protein drinks, out to the couple of encampments that we know that are off of Valley Avenue did that a couple of days and we'll probably do that again today. I can get some team members here we've got people out so that's what we're doing here and and then just trying to supply we had greater likes host team out here yesterday, just trying to supply them with the people that they're serving so they're able to pick up some things and take them with them.

Thank you, Paula for that. And Jessica anything you have any particular needs or things that you need for the outreach that you guys are doing right now? I see you're on the call. But if you can't unmute, it's fine.

Jessica Hall

Sorry, one second. I'm in the car. And we were on a phone. So okay, um, no, not in particular. We're actually kind of on a roll with housing people. So it's taking a lot of time. Um, but we we've had somebody every week for like the last three weeks, which has been awesome. And we've got a couple more we have a couple of other options for some people but so we have not been able to get out very much but that's what we're doing today is out handing out stuff for winter. So we're in the liquid area right now we're going to head to we'll probably stay in like wood. We've got a lot of assessments to do here today. But that's where we're at. Okay, great.

Rob Huff

And awesome news to hear your housing, housing, a lot of people so that actually is a resolution to the problem. So thank you all right, so any last items that folks want to share related to on the streets before we move on? Alright, so let's transition real quick to just a reminder about the need and share dt. Jan, do you want to talk about that or J or how do we want to do this?

So right now, the Google Sheet is pretty much exactly how it was a couple of days ago. But if we could start adding to what we have, by tomorrow, there will be a simplified version of that with numbers and otherwise currently when you're adding your need and share, just go ahead and go to the bottom, add the date. And then in the descriptor, if you could add the number of things that you need so that we can start getting that together. And then I can start searching for the item with the accurate number and starting to get the accurate information. The more that goes there, the more I can do and I know that some of you can't access or don't have the time or otherwise, if you could just send me a list through email of what you need, or what you can share how many you have or how many you need. I would super appreciate it. I understand that the Google Docs is frustrating I'm hoping that after I redo them this week, next week, I can do a presentation and show everybody how to use them, how to access them and the best way to enter information for that. Thank you, everyone.

Thanks, Jay. And Christine has noted in the in the chat that if you don't have access to the spreadsheet and you want to add something just put put it in the chat and she'll add it to the spreadsheet. I'm looking for the link to the Google sheet here and if I get a chance here at some point I'll drop it in the chat unless J beats me to it. So let's see. So let's move on to the next item in our agenda. And we were going to have a conversation about the a couple of items that are coming up before the Pierce County Council starting this next week with opportunities for folks to voice their support for additional funding for affordable housing. So rosemary, do you want to queue that up?

Rosemary Powers

Yeah, so I prepared a five to 10 minutes of background and opportunities that we can take, since this is a new possibility for the county and some of you may know much more about this than I do. So I apologize in advance. For any mistakes I may make and the chronology. But I wanted to share with you how the states set the stage for this tax idea that's coming up what Pierce County has done in the past and how it's now prepared to try to do something as a council. The group that I've been that I represent today is called revenue for housing. I'll make a comment about that group and then opportunities for you to do whatever you can to promote this new idea. So I had a problem with my printer this morning. So I have some things on on the computer so I may be reading a bit from that rather than doing what I usually do so anyway, the state did set the stage for this in 2020. The legislature provided local jurisdictions with a new funding tool to address the growing need for low income housing and the homelessness crisis in the regular session that year. With leadership from Beth Dolio, who was prime sponsor of the bill, there was House Bill 59, which is the source the state source for this potential task tax. The legislation amended a previous taxing authority for a 110 to 1% sales tax into one that can be enacted by a county or city council as as Councilman manically meaning it sounds like maniacally and didn't read that but Council manically by meaning the council itself can enact the tax. Previous law required this to go to the voters for approval. So Pierce County has dealt with this problem and for some time, and we are we ourselves have been involved as a as a coalition and helping this to happen.

Several plans exist for committing to ending homelessness and addressing it. There were comprehensive plans over a five five year plans in 2019. A couple of those. And then the comprehensive plan we've been talking about for some time was was approved in 2021. identified the need quite largely. And it this particular plan did not include broader low income housing development strategies for this, the county sought assistance from Bert consulting, who presented a report in September of this year that called for multiple strategies to begin to address housing funding gaps. And this housing strategy included enacting a quote local tax as a potential funding source that didn't identify this particular tax, but said this was one way the county could get some funds. So the County County Council human services committee reviewed this report and moved for its adoption in the committee on November 8, just this past month committee passed the resolution identified implementing actions and established reporting requirements then this was presented to the full council for vote on that same day. The resolution proclaimed and I quote this because I think it's a significant statement by the council that quote Pierce County must be an active contributor by filling funding gaps and by providing financial support to the construction of affordable housing units in our county, to county itself has been a pass through for most of the funding that has worked for housing. This is a statement that says the county itself that means us as members of the county should be an active contributor to this funding. That sets it up for thinking about the tax. So included in the directions to staff and the housing action strategy resolution was a direction to produce a draft ordinance that implements 1% 1/10 of 1% for housing and related services, sales tax pursuant to all the things that you have to do to get an ordinance passed that goes well with this and doesn't contradict that. The resolution included other implementing strategies with similar directions to staff and I want to just list these because they'll come up in any conversation you have expanding the scope of the multifamily tax exemption, expanding the role of the Pierce County Community Development Corporation, initiating consideration of amendments to increase the state Environmental Protection Act category exemptions and infill exemptions were these are authorized by the state for something that could happen, but the focus of the discussion at the council study session at the council meeting was on and the resulting non unanimous vote on the housing action strategy reflected the inclusive inclusion of drafting than an ordinance to enact a specific tax. So at that meeting for those of you who weren't able to participate or hadn't read about it for members spoke in favor of the resolution and were specific in supporting the idea of attacks. So they addressed the other strategies as well. One council member was willing to adopt this housing action plan as a compilation of approaches but expressed a preference for increasing the low income housing stock by expanding the use of the Low Income Housing Tax Credit rather than enacting a new tax to members of the council voted against the resolution. So we have a five to two vote for the housing action strategy in general, but we need to wait for specific legislative language about an ordinance that would be drafted by staff in order to move forward so while that was a positive result on Housing Act strategy, it was not a real result with regard to the tax it just set up that an ordinance would be drafted. So enter the revenue for housing group. I just want to make a very brief comment about this because some of you might want to want to join us in our work. After the passage of House Bill 1590 and 2020 group has gathered together to encourage Pierce County to adopt a small

tax to create a stable source of funds that could be leveraged for other funding for the housing projects and to cover related services we currently meet every week on Monday mornings convened by project initiator Carolyn Reid, to learn more about the realities of low income housing, and the potential for engaging all kinds of groups in ways that we haven't maybe thought of before. We've testified almost every week for the past two years at council meetings to support this tax and so they've gotten to know us and maybe get a bit tired. of US, but since they know who we are, and with the adoption of this housing strategy, the members who are supportive of the tax reached out to us to talk about their timeline and to consider and see past our support in the past of this tax and encouraged us to share our views with the full council and with our network. So that's why I'm here today in response to that request to share it with this group of which it has already in the past taking a position on this tax. So we've already signed on to this letter as that's one of the actions you can take and individuals and agencies here who work in various spheres and demonstrate there's wide support for creating a new revenue source by signing on as well. Expected ordinance number is 2022 period 81. We don't have specific text, but that will be subject to amendments anyway, so I wanted to let you just know a few things you can do. I don't want to take much more time but I'm going to share a screen that you can read and distribute this one page description. And Rob I don't know if we can send this out to the whole coalition that if we could, that would be website. didn't share my screen. I got ready to do it. He told on his DESeq I have to stretch myself out here a bit.

so this one page, it has two two sides to it. But it includes the information that I didn't present which is what does this tax do what kind of money can we expect it to bring in what is the situation that it addresses? And so this would be something you could use yourself or share with others who may not know about it, or may not know the advantages of this. And so here on the back side of it is the way to get involved. You can contact Chris county council just in support of it and you can sign on to the letter. There is a live link there that can be used. And it makes the point very clearly that a whole lot of other counties and cities in western Washington only there are nine counties and 21 cities that currently support this in terms of the sign on letter Rob said this morning in checking the but the sign on so we have over 240 already signed in on that. So this is a really good way for especially if we represent education, how health care building, whatever kind of groups were part of that we could show that all kinds of people support this. So that's I think I'll stop sharing the screen there. And Robin if you can let us know what how I can make this available to people that'd be that'd be great. Sure,

I'll try to do the best I can. So that's one thing you can do sign the letter of support. Then there's a study session at 930 on December 6, and if you can attend that and speak in support or just send a note to that group that you support, it is not necessary. To have 100 people there but we like to have some and then at the council meeting itself at 3pm on December 13. The council will take up take this up as an item of business. I know some of you were at the time that the council considered the 110 to 1% for mental health and that was like 110 people or so testified it was a very long night. I don't know what to protect to predict here but we can participate by zoom. And some of you may have received an invitation to do this already. So I thank you for doing that. And the revenue for housing group will keep on meeting so if you're interested in dealing more with this, whatever the outcome is, just put your information to me in the chat and I will make sure that you get a zoom link to that. And when you discuss this tax in our breakouts today, which is the focus we have put for it. Be sure to share any ideas your group has about how to talk with other people about the potential and limitations of a sales tax which always affects poor people more as a means to countering poverty. That seems a little ironic, you know, in words, but it may lead you to a new passion to get involved with somebody else who perhaps who's working on trying to change the texting system in Washington State. In the meantime, it's a tool we have that story I can tell about its position right now and want to encourage us all to be supportive of this one way to get some stable funds to begin to address housing problems. So I think I'll stop there and thank you for listening.

Rob Huff

Thank you, Rosemary. Thanks for that overview. And I did see Carolyn, read you're in the meeting. Do you want to add anything? You might not be in a spot where you can chat. So

yeah, no, no, I thank you very much for the opportunity to add something. You know, we've been working on this for two years and it would be so wonderful for us to get this over the finish line. And start setting a precedence that the county is putting a little skin into the game. And I think most want to do that. And the most powerful thing about this tax even though it's 20 million a year, which isn't enough to fill the gap of what's needed of over 600 million, but you can leverage other monies. So this can be matched money for grants it can be, you know, bonded against gives them a lot of flex ability. So I highly encourage you that link did not work for the sign on letter, Rob, but I'm going to assume you can put that in. But if you are able to sign it and able to come to the meeting that would show great support. And we would we would just love to see this happen. Thank you. Thank you.

So this was a couple of weeks ago now. Just a second. I'm like looking at my screen so I had to escape from well will screen to actually look at the document. Okay, I'm done talking to myself. I can talk to you all now. So a couple of weeks ago that we had this discussion and we talked about base basically the dilemma of campsites being fragmented into smaller sites and how to deal with that and how to do outreach to these smaller sites and the sort of broader question of doing street outreach and and what people need. So it begins as always with recapitulation of the great poem there. Rose Marie offered to center our thoughts and then there is an alphabetized list of various outreach items that people brought up specifically followed by a bunch of general out reach advice that I'll just go through, touch on really lightly. You know, everybody loves hand warmers. The hygiene. Cold weather kits are a standard that people always love to receive this advice that's come up here before, think about what people actually need, not just what you want to brand nutritional things rather than maybe donuts, stuff like that. List out key items to provide and listen to people to figure out what that is. Collaborations are essential freeze dried food is great because it's easy to prepare and super lightweight. You can carry a lot of it with you and you're out doing your outreach. caution when you're doing your outreach can be dangerous. There some urgency from moving to the By Name List and and doing the work to make that possible. Um I'm just gonna skip down some stuff about campfires and using hand sanitizer and some recommendations to maybe help people find new places to go. And then people talked about the onesie twosie dilemma in particular and I took those comments and just sort of put them all together there's some great advice in there about how to particularly work with the smaller encampments. There is a whole list of specific resources that people mentioned that are available. So you can look through those and see if there's anything there that applies to you. And then finally, I put an advocacy take action item at the end, not because it came up in the discussion, but because we all need to take action. So another opportunity there. And that's the summary.

Rob Huff

Great, thank you as always, Timothy and even though it's been a couple of weeks this information is really important. So thank you for pulling that together. Oh. Great. So let's shift over to deal breakout conversation for this week. So what we wanted to do is double back and talk about the carve out 15 minutes for folks to talk about the topic of how will you talk with friends and neighbors, friends and family about the potential for a Pierce County affordable housing, sales tax. Our hope is that folks will have an opportunity in these small breakouts to share their thoughts and some ideas for ways that to talk and build support for additional funding for affordable housing. And and as Rosemary said, talk

about the issues around the limitation that unfortunately we have to use sales tax as the vehicle to raise funds for this. And this is one of the best parts of the meeting because everybody's cameras are on when you return. So that's a bonus I get there's actual people in this meeting. That's awesome. So Reminder. We actually had a full 15 minutes today. So hopefully it was a good opportunity also just touch base and network, something that we we miss because we're in virtual space rather than meeting in real space right now. So let's move on to our regular government updates. Do we have I think I heard Matthew from the city of Tacoma was going to be here today. Matthew, are you on the call?

Matthew Jorgensen

Yep, I'm here, Rob.

Rob Huff

Oh, thank you, Matthew. Any updates from the city? Yes,

Matthew Jorgensen

morning, everyone. Matthew Jorgensen from the Neighborhood and Community Services Department with the City of Tacoma. I just didn't want to give folks a few updates and then kind of wanted to walk through some of the camping ban questions as well as much as I can answer them. Just to reminder that capacity for cold weather has been expanded by 125 beds. So the rescue mission is operating the Holy Rosary shelter through March of 2023, which is basically 50 seasonal beds. And then additional in addition to that, the rescue mission downtown campus and nativity house will be operating with that, you know we we hit that threshold of 35 degrees with rain and snow and colder. So that's going to be an additional 75 overflow beds and we've also opened the lighthouse Activity Center is a warming center just during daytime hours, and that's gonna be open through tomorrow from 830 to 5pm. And then I don't know if SARS encampment removals got enough Caleb's brought it up before in previous meetings but the scheduled encampment cleanups are listed on the city's website at City of tacoma.org backslash encampments. It also lists the standard operating procedures for the encampment removal

process, but I'll also put a direct link in the chat for the scheduled encampment removals. So for my understanding how the process currently works is that folks staying in the encampments within a 10 block radius are given an initial notice that they're within a prohibited area. And then once all those encampments in a given 10 block radius are given notice what we're calling sufficient notice those folks who doesn't candidates will then be given a second notice with a posting date foreign camera remove. The current focus area is in the 10 block radius around 35th and Pacific with ongoing acumen cleanup at 34th and Pacific and the cleanup of the encampment along south to come away between Pacific Avenue and M Street. I'm scheduled to begin today. And just so you know as listed on our website, the next 10 block radius area scheduled to be given notice will be surrounding the stability site. And it's my understanding that the schedule posted on the website isn't necessarily set in stone, but will be updated if and when things change. So I'm happy happy to answer any questions I can possibly answer and thanks for having me today.

Rob Huff

Thanks, Matthew. I do see Ryan has the hand up and then Jay

Rian Booker

and Matthew, I was just curious because you know through the fall, the city's been rather aggressive the sweeps and moving a lot of folks, could we kind of put a line in the sand to say okay, after this date, we're going to take a holiday on sweeps until, you know, February just to allow people during the cold weather to kind of stay where they are, you know, they finally get protection and some shelter from the cold and then we pick them up and move them and they lose all that stuff and then they're blank in a doorway. So, you know, I know that there's forces on both sides, you know, want to move but you know, after this fall, you know, it'd be really kind of nice to just say, Hey, we're gonna let people shelter in place to stay warm and survive the winter. And then we can you know, get back to business as usual.

Matthew Jorgensen

Thanks, Ron. I can definitely bring that feedback back to leadership.

Rob Huff

Yeah, and thank you for bringing that up, Brian. I appreciate that idea. Jay.

Jay Warley

I just wanted to thank Matthew for being here and remind everybody that he is very new to the position and is missing quite a bit of information and is learning his way with us. And so if we could be kind and ask questions and regards and see where we can go with good communication with Matthew, it would be super appreciated.

Let's move on to the latest updates from Pierce County Human Services. Jeff, any updates for us? Yes,

good morning. We're planning for the 2023 annual homeless Point in Time Count that's coming in January. So mark your calendars. January 26. The last Thursday of the month of January is the date that the point in time count will take place. We're finalizing the materials on our website. I will put a link in the chat to our website where you can register if you want to volunteer and anyone participating must register must go through training and you just need to go to our website and fill out the registration form and then you'll be contacted as to how to proceed from there. So we need volunteers. We'll be doing the count Thursday afternoon, Thursday evening and Friday morning. So you can find the details on our website. And I'll make sure that once our public service announcement is finalized by our communications team that I'll send it to the whole listsery, so you have that as well, but I'll place our current information link in the chat.

Rob Huff

Thank you, Jeff. Just for some perspective. Do you have a kind of target of how many volunteers you're looking to line up for this year's Point in Time Count?

That's the million dollar question. We don't have a specific target number at this time. Usually we have between two and 300 people that volunteer the last couple well last year in January of 2022. We had way less volunteers due to COVID in the year before that we didn't do account due to COVID. And historically, before that we would typically have had I don't know between 250 Maybe 350 people somewhere in that range of people that would volunteer for the point in time count. So we're working on it, identifying areas to be covered, and we'll figure all that out. So we're looking for at least several 100 people to volunteer.

Great. Well, as soon as those materials are finalized, we'll make sure to spread the word through the coalition mailing list and that sort of thing.

Jeff Rodgers

I hope I'm successful. I was successful. Okay, I put the link in the chat for our website.

Rob Huff

Perfect. All right. So let's see. I saw Valerie on the call earlier Valerie any updates you need to share with us.

Valeri Almony

Good morning, just that we plan to open the permanent rental assistance program around January 3. If that changes, we'll be sure to let you know the requirements and eligibility should be coming out here in the next couple of weeks. And we hired a new rental assistance staff member so I am no longer flying solo after five months or six months at this point. Super excited. Her name is caress she's amazing and I will have her pop in to say hello. But you're still all your communications will still go through me. We don't want to bog her down just check. So that's it for me.

I'll start I guess. Um, hi everyone. Jenny sheppy Tacoma Pierce County Health Department's communicable disease. I I know folks are very very focused on the weather right now rightfully and keeping people safe and alive. But here I am over here banging the drum for communicable disease prevention as well. Just always, always here doing that. You should have all received GOV Delivery. You know our official TPC HD like email. He knelt serve service. For me, hopefully today. It's got lots of COVID and flu resources in it. So I won't go into detail right now. But with more folks being inside, you know, coming inside to warming centers and such I want to make sure that folks reach out to me if you need masks. I have a surplus of masks right now. And I can meet up with you I can deliver. We just want to make sure that with more folks in hopefully, it thankfully inside warming up that we do still keep mindful about disease spread and trying to get folks to encourage folks to wear masks, especially if you have symptoms. We are showing though with our COVID data shows that a loose, slow steady low steady rate of hospitalizations which is great news. So things are staying really really steady that there we have a lot of flu and RSV, other viral, you know, respiratory diseases circulating through the community right now which are putting a strain on our hospital system. So, again, in my email, there's a lot more information and links how you can learn more about RSV and flu and prevention. But we're we're having a great winter season. We've been talking about we went straight from summer to winter. It seems like this year unfortunately, I'm working on some flu clinics adult vaccine clinic happening at Tacoma rescue mission next week and so far that's just for come rescue mission guests and out their outreach team and to get the word out. But I'm hoping that that I'm working with TRM to see if that can be opened up to to other folks to come in to get flu vaccine, and I will keep this group updated on that. Monkey pox, which is now called M pox. slow steady. No, I mean plateaued, basically not a huge concern. But I can share the vaccine page if you know folks that are eligible. And finally we're still really concerned about congenital syphilis in the community. Our STD team did do some, a lot of outreach and get folks connected with testing at the 14th and G site before that was swept. But if you have questions, I'm going to put the names of a couple of our STD team members in the chat and you can feel free to reach out to them directly or reach out to me and I'll connect you if you're more comfortable with that. And I will turn it over to Adam and team unless anyone has communicable disease related questions for me

Good morning everyone. Adam rakin burger I use he him pronouns housing policy coordinate Nadir with Tacoma Pierce County Health Department over in the Environmental Health Division, eh, as we toss around a lot and confuse people who don't know these terminology and acronyms we have. Hi Valerie. We the Environmental Health Division has activated with the cold weather response. We've been participating in inclement weather, morning meetings, we will continue to do so. A couple other things. We're still having our winter cold weather clothing drive going on at our D Street location trying to collect items there. It sounded like in this morning's meeting that another clothing item that's kind of being missed right now. I believe. Courtney had mentioned hats so just want to make sure we clarify that's cold winter weather cold weather winter hats that cover your ears I think was was a need. So if there's any other needs like that, please feel free to drop them in the chat. I think we are pretty plugged into that needs, needs uses needs and haves list that Jay has put together. So you can also just put them there and we'll be able to read through that and encourage health department folks to identify those items and deliver those items if they can't. This morning. Our new colleague Isaiah co karate joined earlier this week helped to deliver backpacks to the lived experience coalition that had winter weather gear and some medical supplies. Some folks I hope got to meet him in person and he was also able to attend the collaboration for a cause event yesterday where we passed out some cold weather gear and information. One of the other things that's also relevant to this larger group we are ordering cold weather injury kind of like wallet cards that I believe they're supposed to be weather resistant for folks to be able to carry with them to hand out to folks around the street to help them be prepared for signs of hypothermia, frostbite, that type of thing to be able to respond and move quickly if need be. So the other big news, which I mentioned as a co crop has joined our team earlier this week is our environmental health homeless liaison so similar to Jenny's role as kind of this this group's point of contact for communicable disease concerns. Isaiah in the future will be your point of contact for environmental health concerns. So thinking about inclement weather, particularly cold weather, warm weather wildfires smoke if there's for get into some type of like water contamination and stuff like that. He'll be the point of contact there. So we're super excited to have him on board. He's here today and I just want to let him come. He's already on camera. So let him introduce himself and say hi.

Isaiah

Yeah, thanks, Adam. So as he said before, he basically just took my entire introduction away from me, so that's cool. But so yeah, I'm Isaiah Cockcroft. I have met some of you here and there. I met Courtney, earlier today. So I think when he's around here somewhere like he mentioned, we dropped off some cold water supplies like backpacks and blankets and things like that sort. So that was really awesome to do. It's my fourth day, I believe. So I got here on Tuesday, so I'm still really new just trying to get copied with everything we're doing over here at the health department to this meeting everybody

I've been a provider here in Plumas County for a little bit here. So I've come from more of the Social Work perspective, but I would love to hear more about what y'all are doing in the public health field and whatnot. So I'll go ahead and put that in. But like I said, my door is pretty open. I'm still onboarding, but my schedule is somewhat flexible. So if anyone wants to reach out to me, I'm more than happy to do that. Great,

are glad to have you here Isaiah. And welcome to the new job. All right, and I would call on somebody from Pierce County Emergency Management. I don't I think Ivan was here through the breakout sessions but he needed to leave. So I don't believe you have anyone else from Department of Emergency Management. But let me pause here for a moment just in case. All right. So that is not the case. So briefly, I wanted to offer something for our advocacy updates. We talked quite a bit earlier this morning. Thank you, Rosemary for braving the opportunity to advocate around the affordable housing sales tax. So that I'm not going to reiterate that information here. But I do want to let folks know that the Pierce County comprehensive plan advisory board is meeting this afternoon from one to three. If you have the time to attend, it would be a good one to tune into. The reason I say that is that the bulk of the meeting is going to be a report from social change partners, the consultant that has been looking at recommendations to the county regarding regarding the first item on the county's priority list for the comp plan which is creating a unified regional approach to homelessness and that is going to be the key piece of the presentation today. Those of us who are interested in being part of the accountability conversation need to be pretty focused on what we want to see come out of that work. And that's not fully spelled out yet. Our safe sites are safe parking sites are talking individually about bringing folks in from cars into their churches that is entirely up to them. That's their choice. If anybody has any suggestion of a new site or new partner, please get in touch with us Paula, take it away.

Yeah, just like I said, the inclement weather. We're filling up our safe parking lots. We're getting people in twos and threes. It seems like there's more people that are coupled up or bringing daughter or son or things like that. So we do have family spots available still still working with the the school district on placing people were one of our families is going to get placed here in the next week. We're really excited about that. So but yeah, we are definitely looking for more sites. I'm also continuing to look because we are getting the grant from the State Department of Commerce for a 20 RV spot location. I'm just going to throw it out to everybody. We are looking for a place potentially that has already paved parking lot big enough to have 20 Garvey's in it. We have money to do some capital improvements to the property. So if it's leased, you know we can do some temporary improvements and we are hopefully going to find a property that has an empty building on it as well because there will be on site case management and where the RV lot. We're looking at 24/7 security, fencing around it, that type of thing. So we're really going to make it safe and palatable to the area that we're in. We are continuing to look we my program manager Jeff's been out every day for the last two weeks looking at different locations. And one of the things that the draft ordinance that the council is reviewing I think this month for say parking included was a map and a lot of the areas that they were looking at that that would be good for site parking, or all along the Pacific avenues Spanaway area. So if anybody knows any buildings out there, that might be a good fit for what I just described. Please contact me I'll put my email in the

One is that this is for those of you who don't know, this is the quick thing. We put together bags and stockings mainly bags go out to people who are unsheltered on Christmas Eve or Christmas Day. We work that out with whoever is delivering them. And we also take some smaller things to the shelter. So if you're involved in any of those things, like I was thinking about, we haven't done it for FOB out but that's something that they're interested we could look at. So if you're in in a situation like that, where you might like to have some of these, let me know and what I do is expand this to the space available for people who are willing to do these things. Sometimes the bags are kind of smallish sometimes they're giant, it kind of depends on who shows up, but we make sure that all of the bags that go to any particular site are really similar. So we actually have a Boy Scout troop working with us this year, one of the one that Garrett is working with so if you know of a group like that, who might be willing to put together 30 bags and then deliver them either to me and I would be the person who would get it connected to the outreach worker. The coalition mailing list has 700 folks on it and and planting the seed to see what we can grow for the holiday season there might be helpful too. So if somebody wants to take that on that would be good too. Um, let's shift over since things have slowed down a little bit to talk about any good trouble announcements, things that people want to share with the 54 of us who are still here in the room. And all the common says is just let us know you're doing it but there's no need for a permit. So that was yesterday and I just got an email from the county on the point in time count. And I'm now signed up for the point in time count. So and I've done this for five years. Please, please please sign up for the Point in Time Count. We need more and more volunteers.
