Rosemary Powers

Welcome, everyone to our open table where we connect every week with respect for differences, to act in homelessness and advocate for policies to ensure safe and secure housing for everyone. We gratefully acknowledge that we do this work on the traditional lands of the pupil of people who've lived here since time immemorial and are still here today. They live and work raise their children take care of their communities and practice their traditional ways and speak the same language just as their ancestors did. Today, I bring a few thoughts on advocacy. During the meeting we'll hear about legislative priorities and how to bring our voices to the development of supportive public actions for me it and long range housing needs and we'll talk with each other about our own plans for advocacy and learn a little bit how to do it better. And advocacy is an old idea that comes from that Latin word Advo Caray, which means to add voices and it can also mean things like lobbying. Standing up for rights fighting for change champion a cause changing the system, those sorts of things. And we use the word as a shorthand way to describe acting to support things that are important to us sometimes with other people, sometimes with a lot of planning, sometimes out of a deep sense that we just can't stay silent anymore. And it makes me wonder, why do we so often choose to keep silent or stay silent until we feel compelled or that we have to add our voice? To understand this I'm drawn to the work of Audrey Lorde,

a black feminist, and one of my favorite writers. I've shared some of her words before and when I was teaching sociology, the small rural University in Eastern Oregon, I had a poster on my wall that had a quotation from her talk she gave in 1979 at a New York feminist conference. She said, quote, When I dare to be powerful, to use my strength in the service of my vision, then it becomes less and less important whether I'm afraid. That poor that poster served as a persistent pep talk when I found myself being silent about important but difficult issues. And with these words, she restated what she had imagined earlier in 1978 poem called a litany for survival. I think I've shared it here before but just she reminds herself as a person, living at the margins of power that when we speak, we're afraid our words will not be heard nor welcomed. When we're silent. We're still afraid. So it's better she said to speak. remembering that we were never meant to survive. So this assessment of silence as fear resonates with me, and those times I judge that I've not spoken if my speaking might make things uncomfortable for someone else. Or I wonder what negative will happen if I have a different position on a subject since I'm not an expert in very much or when the differences between us just seem to Great Lord died of cancer in at 58 in 1992, and as she reached the end of her life, she spoke even more strongly about the effects of silence and the Power of Living into speech in spite of differences even when we are afraid. Her words challenge us to add our voices in the public arena persistently, and insistently demanding action on the humanitarian crisis of housing and homelessness we see before us every day. We can learn to work and speak when we're afraid, she said, in the same way we have learned to work and speak when we were tired for we have taken away excuse me, we have been socialized to respect fear more than our own need for change and language definition. And while we wait in silence for that final luxury of fearlessness, the weight of the silence, she said will choke us. Finally, the fact that we're here she says and that I speak these words is an attempt to break the silence and bridge some of the differences between us, for it is not difference that immobilizes us, but silence and there are so many silences to be broken. So welcome everyone to breaking the silences. And adding our voices to this important topic today. So welcome to the coalition meeting. And just for those of you who are new a couple of points about how we run our meetings, we ask that people keep themselves on mute when they're not speaking, and that you stop your video if you're doing other things that might be distracting and then we have the chat as an option to use here for discussion and questions and updates, resources, putting your name in there and your your contact information if you're interested in something or come today in the hopes of having a connection with someone on a topic that is important to you and so we ask that you use for that function that can go pretty fast sometimes. So you might have to pay attention in case someone's trying to contact you directly. We save the chat and it's available on our website site at a later date. You can also save it yourself. And we have a list of community norms that usually Rob puts in the in the chat for you to see. And these are the basic norms of respect for our differences. Since we do not expect everyone to agree. We did not expect everyone to have the same amount of things to say. We want to make sure everyone does have a chance and that we are respectful in our disagreements about policies and issues. So with that, I'd like to welcome anyone who's new today just to let let us know that you're here, say your name. If you're related to an organization or an activity of some kind, you did mention that it's not a time for a general introduction, but just so we know that you're here and that we want to welcome you very much to our space. I just want to introduce myself. My name is Mindy McCoy. I'm new to Washington. I'm with I'm the new community advocate at rebuilding hope that sexual assault center prepares County and I'm just looking to network and kind of navigate Washington and find out what spaces I want to volunteering and get involved in and just network with people and get to getting involved. I mean, I just want to be involved and be the best advocate for my agency and just be a community partner. And so that's why I'm here. Thank you for having me.

Welcome Mandy and that's a dangerous thing of course to say but I hope you'll find this space of welcome one all right, well if you if you are new or returning from being a long time away and want to connect with people, be sure to put your information in the chat and any information that would help others connect with you. Rob, alternate back to you.

Thank you, rosemary, and thank you as always for getting us started down the path for today's meeting. So let's shift to our first regular standing item that we do every week and that is talking about what's happening on the streets this week. This is a segment of the meeting where we urge those who are doing direct outreach, or those who are just observing the changes in the needs in your own neighborhoods, to share what you're seeing what might be needed out there in the community across

Pierce County. And and, you know, share how the group of 53 people in this room might be able to help whether it's with supplies or other support. To put this this week in the streets for this week in context. We're gonna be looking at some wet weather coming in over the weekend. And some windy weather but the temperatures our overnight temperatures are due to be quite cold again next week. So I would anticipate we're right now the forecast is looking like there's a number of days next Thursday through Sunday, where we could see temperatures in the mid to upper 20s at night. So cold weather gear will be much needed again by next week. And so that's a little bit of context for today's conversation. So just use the raise hand function or raised your physical hand so I can see it and let me know if you would like to share about what you're seeing on the streets

Yeah, Bob. Good morning. The last three weeks in the Gig Harbor Key Peninsula communities we have identified 10 New homeless families three single men, three families with kids and three women. That's a that's a huge increase for us. And I think the weather has something to do with it. But grm has to have the parents with kids set up in temporary housing, Jessica at greater lakes is embracing three others working with them. The other the other three have not been interested in help yet. But we're as a community reaching out and providing them with tents and tarps and food. But it's it looks like we're unfortunately starting starting to hit the peak and glad we have at least a little bit of community support system set up so

that's that's it. Thanks, Bob.

Sorry to hear that you that there's an increase in the number of folks you're seeing there. Hopefully supplies can get out to them with the cold coming just so that they're they're able to get through anyone else with updates from on the streets this week? All anything you would share from East Pierce County?

Yeah, yeah, that's scary. Rob. If you knew what else was in my mind, that would be scary. No, I'm just kidding. So we are. We're seeing an influx of people here at New Hope. I'm assuming that they end their new people. So I'm assuming that they're coming from some of the sweeps that are happening on

all also. We continue to supply lunches here at NIU. Hello people come in, they can get warmed up from 8am until we close around three they're able to do that get clothing I just received I wanted to let all the outreach teams know i just received yesterday boxes of gloves and scarves and there are a few beanies I need to order some more but as part of what we're doing is being a supply place for outreach groups if they want to come and get those items. I just wanted to let you know I received about 400 of those. So we're started on that being able to hand those out to whoever wants them. So just wanted to update you all on that.

All right, thank you. Thank you, Paula. And I see Alan, Alan Brown on the screen as well Alan any updates you can offer for how things have been going on at the day center.

Alan Brown

We've been steadily busy. I will say that we just got in a big donation of coats and winter wear from zoomies just yesterday. Good.

Just in time for the upcoming cold so that's great news.

Great news.

Let's see any buddy else listen on the streets update. Richard anything you'd like to share from what you've been saying?

Richard Dorsett

Um, no, just more of the same. We've been doing a fair number of coats lately and just keeping an eye on things getting ready for next week with more cold weather but we've been hitting the goodwill outlet pretty hard getting inexpensive good quality winter coats. Good, that's great.

All right. So if anyone else has things they would like to share in regard to what they're seeing on the streets. Please feel free to use the chat. I will paste the link to the city's website that where I think it was Matthew last week from the city who I see us on the call shared the link to this page. It shows the schedule of the city sweeps and clearances that are scheduled or notifications that are scheduled related to the camping ban. And so yeah, Timothy, I'll take a look at that story as well. I don't think I've watched that one yet. But as you know, the camping ban went into effect in the middle of November and right now postings are happening across the city in those buffer zones 10 block buffer zones

around city sanctioned sites that are there in existence. It looks like so the posting is all done around the site at 35th am Pacific. The postings should be done next week, potentially around the corner stability site down on piolet Avenue. And looks like postings may have already started around Bethlehem Baptist Church. So Matthew, maybe you can address that when you give the city update here a little bit later. Before we close out are on the streets section. I want to remind folks about the need and share spreadsheet where folks can offer an update about what the what needs they have and also share supplies that they may have. Jay, do you want to do a quick mention of that and share the spreadsheet with folks in the chat?

Jay Warley

Yep, I'm pulling up the spreadsheet right now. It is the second tab at the bottom of the spreadsheets when you open up that first spreadsheet you'll see where it is kind of like instructions to use the rest. On the second page, go ahead and just scroll down. It looks like it's in reverse currently to where it starts in October at the bottom and goes up. Just go ahead and go to the bottom and add whatever you need to if you have something priorly put at the top put that you're updating or put an update date by the prior entry so we know that it's been reviewed that it is correct as of today. So hopefully all in all things should have a up to date today. Or and have been updated at the bottom list and state so with today's date so that we can see what is current. So as long as we have that information, that's great if you have a hard time with the data sheets or you just don't have time, go ahead and make a list with numbers of what you have or what you need and email it to be inclement weather listserv. Thank you.

And that's a great reminder Jay, for me to let make sure that everybody in the room here today is aware of that new listserv. I think we mentioned it last week's meeting. But if you go to the PC homeless.org site and scroll to the look at the top of the page where there's a link that says listserv, you can click on that link and go and put your email address in and you'll see the number of different coalition related mailing lists that you can join the newest mailing list is the inclement weather listserv. So if you have an interest in helping respond to inclement weather, whether it's the cold right now or heat and smoke in the summer, consider joining that listserv and it's a way for folks to send a message to to a large group of folks who have a common interest around helping people during the bad weather. J

Jay Warley

one other thing, if you just got a shipment of donation, we're trying to track those donations so that we have a number of what has come in and what goes out for d m and other responses. So even if you don't want to share it and you don't need anything else, if you have donations that you're using for cold weather and or inclement weather. Please also add that to that Cher's needs page. Just Say No need no share. Just data or just information or whatever may have you to say that that is separate from the rest so that I know what is going in and what's going out. And we're trying to get something together by the 15th Per Diem and human services so that they can see how much we actually use and what we're

going through so that they can start preparing accurately for inclement weather events versus cold weather events. And give us a little bit more breathing room with these these weather situations. So the more information we have the better. Thank you, everyone.

All right. So let's see. I don't see so the next thing on our agenda is a community spotlight about Hunter homes and shelters. I don't see Elena on the on the call. Elena. Are you here? All right. Maybe Elena will join us a little bit later. So we'll shift that shift away from that and I also don't don't yet see my coworker from the Housing Alliance poll on the call yet so I'm going to shuffle our agenda just a little bit and

Cynthia Stewart would you like to to go before po in terms of the advocacy topics?

Cynthia Stewart

Sure, I can do that. So give me one second to get organized. Because I wasn't quite ready. But the one Yeah, no sound not a problem. So let's see. Okay, so I want to say thank you for the opportunity to do this. My name is Cynthia Stewart and for a number of years I have worked on issues of housing and homelessness not only here, but at the state legislature representing the League of Women Voters of Washington, and closely in conjunction with the Washington Low Income Housing Alliance. For whom Rob now works and po who will be talking to you later. But one of the things that I do with the league here in Pierce County is talk with various groups about how they can have an impact by becoming active with their city council's the county council and or the legislature and I want to acknowledge that some of you know this stuff really well already. So these comments are really addressing people who haven't spoken with elected officials before. And I'm moving directly my comments to what is coming up next week as opposed to a broader discussion of advocacy. So for next week's conversation with some legislators and some county council members, you will be assigned randomly to a group not knowing in advance which elected official will be in that group. So I think I'm suggesting that you plan ahead for either case, either a county council member or a legislator. And here are some simple things you can

do between now and next week. So that your time with the elected official is really used. One important thing to know is that elected officials are used to no more than 15 minute meetings with individuals or groups, which is not much time and testimony in committees, particularly in the legislature is typically limited to less than three minutes and frequently lately the legislature has requested that people giving testimony do it and only one minute. So think about how in the world you convert a very complex topic and request down to 59 or 60 seconds. getting your point across effectively and quickly requires some advanced work. So next week, there will be about 20 minutes and breakout groups with the elected officials and they want to know in that session, what is important to you. So I'm going to share my screen and provide up it says it's tabled.

Let me fix that for you. You now have that ability.

Cynthia Stewart

Thank you. Okay. So here we go. So basically, meeting with legislators requires some planning ahead. And then by legislators, I mean, legislators in the local government as well as the state legislature, the legislative branches you city council or your county council. So planning ahead is super important. Think about what is your overall message? What is the story that you want to tell to illustrate the message and stories have become people talk now about the word narrative narrative is become frequently used as a way to convey something by giving an illustration it's very personal and emotional. And then think about why this message is important. So then craft your message. So define the issue that you want to talk about. Say why it's important to you. Tell the legislator why they should care, and then tell the legislator what you want them to do. So it's pretty simple. And this is a blurry image, but it's something that I gathered from years and years and years ago and I've been using it a lot. I want you to look at the hand and not try to look up the words on the on the image in the middle. If you think about how to do this, put your hand up. Your thumb is introduce yourself. Your first finger is what is your issue. Second thing is why you care. The third finger is why the legislators should care and then what are you asking them to do? And so I think this hand is a really good image to kind of remember how to do it and and to plan ahead. So and the final thing I want to leave you with is be sure to say thank you both in the meeting next week, but also send a follow up now. Get your legislators email and send them a note saying I met you at the coalition. I was in this small group and I want to thank you and then reiterate your message. Same with the Pierce County Council members if you get to talk with any of them. So that's that's really all I have to say right now. And I'm going to stop my share and see if anybody has any questions. It's very simple. I think another key point to remember is legislators are just like us, they're just regular people. The only difference is that they're they're under some pressure. They're under pressure to try to figure out among other competing interests, what is the most important thing for them to do so that you shouldn't be afraid of them in any way? Just just kind of recognize that their job is a little bit different than yours. I will stop there. I hope that was helpful.

Yeah, I think so. Cynthia, and it might not be clear to everybody in the room that that one of the things we're devoting the majority of next week's meeting to is this meeting with local elected officials. And so that was why we thought it was important to kind of queue up this topic ahead of that conversation. Just to let everybody know about an hour of next week's meeting will be devoted to that from about 930 to 1030. So, so we wanted to give everybody an opportunity to be a little bit prepared for those conversations and ahead of time, so it'd be great if anybody has any questions.

Yeah, Rosemary.

Rosemary Powers

This isn't a question that I've been I've been emailing legislators for their ability to attend and right now we have either seven or eight folks who will come represent the 25th to 26th 27th to 28th to 29th legislative districts and represent to have the new count of the re elected or new council members to the Pierce County Council. And we have three senators and three representatives. So we'll have a wide spread of responsibilities and areas to which people are responding to which people are accountable, that we can think about these messages to you won't be necessarily in a group with your own representative. But the points that Cynthia makes are still really powerful and I really appreciate the idea of following up. I wanted to make one comment about the kinds of responses that can be made also publicly, since we have columns in the newspaper that often get read people responding in ways that are not very helpful. So while that isn't a legislative comment we could always amplify the voice of a legislator who's supporting something we care about by making those comments in public places too. Thank you, Cynthia.

Anyone with any questions and also know you can drop things in the chat because I believe we can address questions there if you don't want to do it on on screen or on in public. But I do look forward to next week's meeting and appreciate you queuing it up before us since Yeah. Yeah. And so I'm looking at our agenda, and I don't see po yet joining us so I'm not sure I haven't heard from him yet this morning. So I'm not sure if he is having technical issues. But let's go ahead and move on to other items on our agenda. And hopefully a poll arrives we'll flip back over to that. So I didn't see. Looking at who's in the meeting, rosemary, would you like to talk briefly about an update on what's happening with the affordable housing sales tax has been proposed at the Pierce County level?

Rosemary Powers

I can last week I spoke a bit about this in an overview way. And so a number of us went to the Pierce County Human Services Committee meeting this last Tuesday, where they did pass it, pass it on with it to the council council was it do pass resolution that was majority in the committee not unanimous. And

so the next meeting for this tax will be a vote to take in this coming Tuesday at the regular Pierce County Council meeting. And those of you who are new to the area wouldn't know this but Pierce County's charter requires that for funding issues, there'll be a super majority of votes in favor. So it's a seven member council and requires five members of the council to vote to approve. So it's not a simple majority. And at this point, there are four votes that support this new tax and they need five so it's a matter of who might be a person who's willing to who's not a tax supporter in general who might be willing to support this tax. There are other parts to this story and yesterday of Matt Driscoll presented the column in the Tacoma News Tribune, which if you haven't seen it, I recommend that you do it. And I would recommend and this is what I was mentioning kind of previously, to tell someone like Matt Driscoll that you liked what he had to say is an important thing to do publicly. So this is not in also, you could do at the same time support the council members who are put this forward because they've they've taken a political gamble at this time that it's worth trying. And what I liked at the last one of the last meetings, we had been a group of us that's called revenue for housing, which is basically the group I was reporting for. We met to describe what we were wanting to do in this last week of trying to get people on board and to come on Tuesday and testify is something that Beth Dolio who was responsible to be the prime sponsor of the bill 1590 in the legislature that made made it possible for local jurisdictions to pass this tax without having to go to the to the constituents is she made a comment and I see Cynthia is ready to comment to a comment about Cynthia saying, persistence is the idea here and even if we don't get this passed, this time, it's the beginning and the middle and the later part of a campaign where it's obvious that we need more community resources to leverage the money that is available in other places to create the housing we need. So that's the short of the update. There may be more in the Tribune and I encourage you to pay attention because there are efforts to ensure that local paper provides information to people who may not know about the ramifications of his tax. So thank you.

Rob Huff

Thank you, rosemary and Cynthia your hands up.

Cynthia Stewart

So I just want to supplement Rosemary just said number one, the last point there will be an op ed in the paper on Sunday, I believe so that that would be important to keep an eye on and support that as well. Just additional background about this local option sales tax. It's very It doesn't cost much for most of us but it generates a lot of money for the county and they can use it for matching federal and state grants and for public private partnerships. The tax was actually authorized way back in 2015. The league of women voters did a study on behavioral health back then, because it was us a second tax for behavioral health that was either raised or at the same time. But it wasn't until Beth's ordinance in 2020. Or excuse me statute in 2020. That changed it from a public vote to a councilmanic vote that the Pierce County Council finally adopted the behavioral health tech but for some darn reason. They just can't seem to get their heads around this housing tax. But it could be extremely valuable. One of the arguments I've heard is from some of the people in this group, frankly, is that it's regressive and it will

penalize those with the lowest income and I just want to point out that it's only on taxable purchases. So many people at the lowest income level are not buying a lot of foolish things for sure. And and the money will be dedicated to helping the people at 60% Ami and below so it will be very beneficial for people at low income and the rest of us should chip in and do this. So please, please, please make your county council members know this weekend that you want them to do this on Tuesday. Thank you.

Thank you, rosemary and Cynthia for queuing that up. This is an important vote. So if there's an opportunity to attend that meeting next week at 3pm and make public comment there's a real opportunity there to to make an impact and potentially lead to additional dollars coming into our county. Alright, so I still, excuse me don't see o in the room. So let's shift in do our breakout conversation. But before we do that, Timothy, would you like to do the review of last week's breakout conversation topic?

Tim Harris

Yeah, happy to do that. Let me grab that. and dip it in the chat. So Ana, rabbit there it is. Um, okay, so what we talked about was the affordable housing sales tax. So this actually comes at a pretty great spot and the agenda. I'll just briefly summarize the talking points that people raised in some of the questions and concerns that were also raised around it. You know, the talking points won't be news to many people. The urgent need for new resources for housing, housing being a human right essential to a healthy community. The importance of talking about the cost effectiveness of prevention and funding and Prevention, the difference that that makes the impact the impact trade off where you have a relatively small impact upon the individual but a large impact upon the community with this tax and not so much focusing on the tax itself, which is something that is generally unpopular for a variety of reasons, but focusing on the outcomes and what this is going to make possible. Some of the concerns that came up were also kind of unsurprising. There was a request for an elevator speech on this I don't know if maybe somebody feels like typing that into the chat. Um, and, you know, the usual conversation about the unpopularity of taxes, particularly regressive taxes, and the lack of options around that yada yada yada. And transparency, talking about the importance of transparency around this and excuse me, a suggestion that the effectiveness of the behavioral tax behavioral health tax that people talk about that maybe provide some information about that, to help make the case and also talking about the vulnerability at this period of folks who are elderly and on fixed income and and disabilities and that sort of thing and who this is really going to impact. And then there were a whole category of notes that I kind of interpreter's county politics. And frankly, the notes were kind of telegraphic, and I didn't really understand them well enough to be able to explicate them but there they are. For those who know what they are, and that's about it.

Thanks as always, Timothy for putting those together and, and, and taking a crack at that. The comments about county politics. Yeah.

Rob Huff So,

with that in mind, let's shift over to actually hold today's breakout discussion. And what we wanted to do was to ask folks in networking slash breakout sessions and small groups to talk about what you're prepared to advocate for in 2023. And what else what do you need to be to feel like you can be successful as an advocate so I think what Cynthia just shared is a good primer on the how to talk to your elected officials. What else can you use? I did see you know in Timothy's notes, the idea of an elevator speech for given topics and that that's the sort of thing that we would love to hear from people if there are specific topics or those kinds of things that you want to discuss in the breakout groups. Let us know. As always, we'll go into breakout rooms here with five or six people in every room. And Please assign someone in the room to take some notes so you can come back here after our 15 minutes of networking. We'll ask the whoever the note taker was to put those notes into the chat so Timothy can do a summary. The key is whoever's taking notes. Matthew Jorgensen

Yes, I am Caleb's out again this week. Morning, everyone. Matthew Jorgensen with the Neighborhood and Community Services Department with the City of Tacoma, wanting to give you guys a few updates, but I'll start with the encampment cleanup just because that came up earlier. As you see on the website, the area around the stability site is scheduled to be given notice next, but I just heard that it sounds like that might be on pause. As far as the actual encampment cleanup goes until the new year.

So there'll be given folks notice, but it sounds like the actual encampment cleanup work won't start until January and then just a heads up on Tuesday next week. At noon, our department will be given our quarterly homelessness update to city council at their study session. So you might want to tune into that. See what we've working on now. We're gonna be working on in the future. And then additionally, some good news I saw Tammy was on here earlier now she is now but we did have the fire department, fire marshal go to follow up yesterday and kind of sign off on those heaters being used in the tents which is great news for those folks staying down there so they can stay warm. So I'll put my contact info in the chat if you guys have any questions or want to talk offline but that's that's all I have for today. Thank you Rob. Thanks, everyone.

Rob Huff

Yeah, thanks for being here. Matthew and Chikwawa. I saw you wanted to give a quick quick city update as well.

ChiQuata Elder

Yes, thank you. Um, as many of you probably know, I'm quite a elder with the city. It's almost opposite equity, human rights. And I'm actually the landlord tenant coordinator. So we provide information and referrals to both landlords and tenants. But we're also tasked with writing the updating the city of Tacomas rental housing code. And so then we're in the process of doing that. And I believe, CeCe from your group. Is she still here, Rob?

Rob Huff

I see her in the room right now. Yeah.

ChiQuata Elder

Is the representative for your, your organization. So what I kind of wanted to stress is we're getting ready to do our education and outreach component to the community around the proposed housing changes, the rental housing code changes, and one of the things that we are focusing on in our rental housing code is shared housing. And so and that's not like to put like too many regulations on it to where people don't want to do it. It's more about ensuring that tenants are living in safe habitable housing. If a landlord has a master lease, and the tenants are paying their rent to the landlord and they're not paying it to the owner, that the tenants aren't surprised if the eviction process starts. And it's about not overcrowding or renting spaces that aren't habitable. So we just want to make sure that there's some protections for people that are living in the rental housing unit, but then also with the landlords who have tenants in there. So we're going to start doing some outreach. And so CeCe will be coming back to you guys. I don't know how you guys do like with updates. And so we'll be asking for input from each of you or from your organization on the proposed changes, but then also we may be asking you guys to like when we have to go before council to be at those meetings and things like that, as well to speak, because transitional was excuse me, shared housing is becoming some people's only

option these days and we don't want people being illegally evicted and then becoming homeless or living in situations that make them sick, or is dangerous to their health or the community. So that's all I have, and we'll keep you guys updated on our outreach plan.

Would it be helpful to do an outreach meeting to this group to the coalition?

ChiQuata Elder

Yeah, we can come in. Do you want to just kind of like get information that way? Do some of those things called when you have like small groups

like a Charette type thing or, you know, the little focus? Oh, the breakouts

like, kind of that around with some landlords who do shared housing type things. We're trying to get some small mom and pop landlords in and things like that. So we can we can definitely come to your group and hold a session and get feedback that way.

Yeah, that would be great. Just let me know when it would be a good good timing for that. And it'd be a good thing for us to do during one of our Friday meetings if it works for you.

And then on top of that, just it'll be very helpful. If you guys would carve out some time for CeCe every now and then to kind of let you guys know like what we worked on and get your input that way. So she can report that as we write the

So we're looking to really stand out make sure that we cover some areas like Pete key peninsula has an amazing team that goes out and covers a lot of the key peninsula but you know if we can expand those numbers into like five area that would be great. There's also some information on donating so we're looking for hats, scarves, gloves, blankets and hand warmers as well. And that information. There's three different drop off sites on that website also.

No. Changes from last week. Were busy training our new person all week, and she's amazing. So hopefully I'll be able to do an introduction of caress here very soon.

Okay, hi, everybody. Um, good morning. Glad to be with you. As always. It was really great to meet some folks in real life at the collaboration for cars event. Last week. That was really fun. So as far as COVID, our hospitalizations are still really low. We did see an uptick in hospitalizations the last week of November. We have had no shelter outbreaks in many, many weeks. The CDC just published results from a study on the effectiveness of the by Vaillant booster and data show that it's very helpful against infection. So get boosted. I'm going to reach out to our congregate shelter sites to try and do monthly vaccine clinics, in quarter one of 2023 to see if we can use some of those. Those COVID funds we still have and get more folks boostin I know we sound like a broken record but tis the season for respiratory diseases. We've got flu, RSV and COVID all circulating so I'm sure if you have not had the flu recently and I hope you haven't, you know someone who has and it's seems like it's been pretty nasty. So get a flu shot. Encourage others to do so the flu shot is pretty effective this year. I will share our our main flu webpage. I also encourage folks to wear a mask if you have symptoms of a respiratory illness. I'm really hoping that kind of silver lining or a positive thing that comes out of this whole COVID experience is that it will normalize wearing masks a little bit because I think that that can really help us protect others. Not just in there you know because of our emergency with COVID being such a concern but with other respiratory illnesses, colds and flus, etc. I'm going to share as far as some community resources I'm going to share a flyer for free adult vaccinations locations where folks can can get vaccinations across the county. I also want folks to be aware that we're working with community health care's hilltop location. They have flu vaccines for the uninsured and underinsured. So please refer folks there for flu shots, if needed. And then the Medical Reserve Corps who we work closely with sort of an arm of our department had a successful event at Tacoma rescue mission vesterday and did several offered several adult vaccinations. Got 14 guests vaccinated there, which was great. We love working with them. Um, I also want folks to be aware and I don't have a flyer or a link yet, but maybe you can jot this down and save the date to come a needle exchange in collaboration with PCAP Pierce County AIDS Foundation are hosting an event January 9 and 10th at Urban Grace Church which is downtown. And I'm waiting on details of all the services that will be offered there but it's it's P Caf. It's our our STD team and common needle exchange all participating. So there should be testing and other resources available. And I will keep folks updated as I learn more about that. I'm finally wanted to share just a few administrative things I'm working with with our communications and we'll be working with our cross divisional group to to create a department webpage which will sort of hopefully serve as like a one stop shop for homeless service providers to find resources from our department. So right now everything sort of disease specific like you have to go look for COVID things you have to go look for STD things or treatment services things and so we're going to try and create a space where someone at an agency who's working with folks in this community could go and see all those links to all those resources in one place. If you have suggestions on what should live there on that page, we're open to that. And then finally, if you are not getting the twice monthly approximately twice monthly emails that come out from us, that had been for me but will be from me and Isaiah and others are moving forward. Please please

Hi, folks, so I'm still pretty new so I'm not sure if y'all met me but I'm Isaiah Corker off and I am with the other one right at the Environmental Health Division as the homeless liaison. Not to too many updates for my end honestly, I'm still doing a lot of on the ground. Work just trying to understand what we had hoped to do and putting all the pieces together but I do have a few things to share out with some folks. I'm currently trying to organize a clothing drive. We did have one a few weeks back over the Pierce County Tacoma health department where we're trying to make that a more sustainable thing going and move forward before we gave it I believe to Springbrook. Whenever the committee is down over at Lakewood, but I'm working through trying to organize that to make it a little bit more broad here at the health department so people can give away things like gloves and hats and things like that. So that can be a more consistent kind of rollout. So that's something I'm working on. Earlier this week. I'm not sure if Tammy is in here but I actually took her to follow up and I was able to meet Tammy who's wonderful. I was able also to meet Brenda Lilly who is on one of our critical reserve team but on the medical research team is kind of getting some more information on the ground of what's going on in terms of our houses, neighbors in terms of environmental health, just kind of chatting. So if you have any interest in me attending live your sites that you can filter or housing program that you want me to come visit and chat with folks. I'm always happy to do that. I really think that like this work has to be done on the ground. So I'm really reading and able to be there and support y'all with that. On top of that more administrative. I'm trying to just organize our cross divisional group as Jodi mentioned. So Jamie and I are working together to kind of get the internal department or some departments of the housing and homelessness services here in each Kamala Harris County Department city a little bit more firmed up. We got like a weekly meeting. It's been relatively new. I believe Jenny and Adam kind of created it back in the summer. But my job was going to be moving forward to kind of organize it and just have a more set like agenda more set projects. So that's a little bit more of what we're doing internally. But yeah, that's currently all I have. I didn't want to ask folks like, since I'm still pretty new to this position, and so pretty new to these meetings, like if people can share with me like what's most helpful in terms of like updates, especially as it might regard to environmental health, so if anyone has thoughts about that you can hop on or even a chat, but I would love to hear feedback from folks.

Ivan from the Department of Emergency Management reached out to Jan and Ron back and asking if we could so back up a step last winter when and summer when we had inclement weather situations hot and cold weather where it was severe enough that the emergency operation center open D Department of Emergency Management invited a couple of members from the coalition to work from the emergency operation center to help ensure that people who were concerned about people who are living homeless currently were going to be accommodated during the the hot or cold weather incidents that were going on. And Ivan reached out to Jan earlier this week to try to further formalize that arrangement. This led to a conversation at the coalition steering committee meeting on Wednesday. And we agreed to to appoint a couple of folks who will fulfill that role going forward. And it's not really something that we needed to vote on, but I just wanted to share it with the full coalition, that if those kinds of incidents take place going forward the two folks that we're going to have representing the coalition in the Emergency Operations Center will be Garrett and J and Jan will be willing to serve as kind of a backup if either Garrett or Jay cannot get to the EOC on South 31st. So just wanted to share with everybody that those two folks are going to be involved if we do get into an extended cold spell or upcoming heat and or smoke situations going forward. So any questions about that from the larger group? In terms of safe sites for all their will the conversations that took place at this week's meeting included. further follow up on what was happening at the veteran's village, the fob hope site at south at second and Pacific Avenue. And, you know, discussion as we do every week related to safe parking status. And we will
