"Don't nobody understands us but us." Seems about right. Even on days when you might think it's quiet on the streets, it's never really quiet. First Presbyterian Church was out delivering food on 25th & Puyallup Avenue. Freedom River Outreach offers meals tonight followed by a freedom prayer after every service. Whatever you are struggling with, they offer prophetic prayer. These are not my crew, but they too are doing good work, providing food and essential services. I also enjoy meeting unaffiliated people who find others in need and who take action, whether it's distributing water, sleeping bags, or freshly made tamales. There is all sorts of outreach underway that is never counted or measured, but it helps people in need. On Saturday, a doctor will visit tents at the Union Street Loop for checkups. Who it is doesn't matter so much, the work gets done.

I turned in my law license many years ago, and this continues as the rare occasion I wish I had not. Another sweep cleared the vehicular encampment at 66th & Tacoma Mall Blvd. where there had been a fire recently.
- Advice of the day, "always have your next camp site scouted." An encampment might be swept or take a quick turn for the worse when stolen cars or traffickers move in. Some resistance is planned for next Tuesday's sweep at 25th & Puyallup. We will be on-site about 9:30/10:00 and you are welcome to join us. I have some resistance posters left over from an earlier sweep and will try to get them up and visible.
- 00:11:45 Sally Perkins: Yes, Pastor Plaehn was amazing. We own and manage five affordable housing houses that we rent to families who would otherwise be displaced from the Hilltop, we do community meals every Friday evening, etc...where a number of unhoused people get dinner...
