WOOT: The Lived Experience Coalition was mentioned and lauded yesterday during President's Equity Executive Order rollout.

Principles of effective outreach

- Consistency
- Important to over-communicate.
- Conversation and less official "documented" feeling.
- Services offered depend on what people are asking for, and what people need.
- In the end it's about "building love and relationships. Love is the real answer, not the system."
- It is important to communicate with the people you serve, to listen to them, to share your name with them, to take the time to show that you respect them as a person.
- We talked about the concept of "joining" which means to present yourself as an equal to the person in crisis. This comes in dress, in actions, in your conversation. This is important because it shows respect to the person.

 Help, but do not give out too much info concerning location because a sweep may come from it and then you start to lose trust.

Barriers to helping

- Outreach and grant requirements are awkward when attempting to help and gain info.
- Part of the reason for not referring is the lack of a good resource list, since resources are constantly changing.
- The end of Pierce County rent assistance was a big blow, and Tacoma pro bono is shortstaffed.

Resources that are most valuable

- The Coalition website at Pchomeless.org
- Networking between providers and social networks.
- Some folks said that they count on individuals and groups like Richard Dorsett, Peoples Assembly, and other mutual aid groups that are helpful and nimble.
- FOB Hope- Van and items in the van help to gain trust. The more you can do with the first touch the better the chances.

Potential open spaces

RI International, Julie Youngblood: We have 2 behavioral health crisis centers, one in Fife and one in Parkland. 2150 Freeman Road E Fife, 98424 and 253-584-2300

New Hope Resource Center has a Safe Parking program affiliated with local churches that puts people on a 30-60-90-day program with rehabilitative tasks to perform. There are requirements for the program, like tabs for vehicle and no felonies. Safe Parking should be considered as a resource for houseless people with cars.

Organizing ideas

Discussion about organizing event with testimonials about sweeps that builds coalition with folks who are low information but not rabidly against homeless folks. Let's work with people who we could bring to our side!
