# What about inclement weather response worked well?

- We are blessed with people in the Coalition who are energized, skilled, and committed to having a strong and effective inclement weather response.
- Communication was good with the County leading.
- Temps were not as bad as expected, things may not have been as successful if things had gone longer.
- Coalition activated due to inclement weather.
- Blankets, cots, hand warmers and such seem suitably available.
- Getting jurisdiction reports from DEM early, getting current information.

## What about inclement weather response needs fixing?

• City was strangely silent.

- Stop the last-minute crisis thinking. Nearly all of this can be anticipated, planned, and stored in advance.
- Volunteers took on brunt of field work. Independent outreach should take a larger role.
- Need a way to support the most grassroots community members helping. We spent \$120 on hand warmers and \$60 on protein bars in February alone.
- Need to do more with outreach, it's hard for a community member to find the resources needed when we encounter unhoused people. Especially needed in Lakewood.
- "When inclement weather shelters open, the supplies, like food, need to be fresh and usable. I went out to ask grocery stores to donate because the food at one inclement weather shelter was old and unappetizing. I got turned down by the grocery stores, so I need help learning how to ask more skillfully."
- FOB vets site struggled without heat into November; anticipate cooling to be a similar challenge.
- Try to figure out a inexpensive portable heat source for campers in winter.
- People being pushed out of other communities are arriving not knowing anything about where to find resources; need a basic map that points to essentials so people don't have to rely on 211.
- Localities and agencies need more microlevel support so disproportionate burden isn't falling upon them.
- Tacoma's sweep policy set a terrible "regional" example. Lakewood has jumped on that non-solution approach. Needs to be more help that 'freaking makes a difference" instead of "freaking criminalizing them."
- "Can't be mad at folks for not accepting a burger when every person before you was offered a burger they just spat in."
- People are harder to find due to the sweeps. "Let's stop using sweeps which continue to add costs to the city and trauma to the most vulnerable communities. Try something new. How many other options have even been discussed by decision makers?"
- When people are in one place the odds of them finding appropriate services goes up. Every sweep is a step backward. We can deal with the problems instead of treating everyone in a camp as guilty of anything that happens. People need to "heal in place."
- We need an ongoing year-round TF to stay on top of the needs for inclement weather and be stocked up ahead of time. And a "quick response" function that we can activate when we get an **unanticipated** weather or smoke event.
- Shelter sites should be able to exceed capacity in inclement weather.
- Heated/cooling busses need to be part of inclement response.
- Lack of information for long term effects from inclement weather.
- Need for unified regional approach.
- We are still looking for that Pierce County dashboard.
- There is both support and a sense of urgency for a "By Name list," and there are concerns that could be resolved by use of nicknames.

- Need more support from Feds and State.
- Need for central information channel.
- There are different activation levels within the county.
