Other Ideas and Areas of Concern ...

 Report back from the City every time they do a sweep, the City may say it's a success because they're gone, but can we get a human impact assessment?

- Can we come up with some sort of directory structure so people on the call can
 identify themselves as a resource and be able to re-find resources after the call is
 over. Maybe a resource corner the last 10 minutes of the meeting to help new
 people announce themselves or ask for help.
- More housing for the aging. More housing for families with children. What are cities and county doing. Hearing from companies building low income.
- Service providers need 24-hour, direct access to available resources immediate help for clients rather than getting stuck on a wait list with no follow up, warm handoffs to help and transitional housing.
- Don't forget homelessness prevention, families with children and elders in crisis.
- By name list, to reduce inefficiencies in providing services to folks in need.
- Corporatization of houses and rental complexes, resulting in rapid increase in rent, lower accountability by landlords, and worse.
- Where is the action on the coming and happening grey wave of older homeless?
 We keep talking but where's the policy?
- Primary topic of discussion was the real need for family friendly shelter options.
- "We're worshipping the God of Coordinated Entry but it doesn't work the way we're doing it now." Need a thorough assessment.
