In the school system, the position that identifies and addresses issues for homeless children in the school system (23,000 students) is grant funded. This is ridiculous. Most of these children are unaccompanied youth.

It's so difficult to follow up with people who are vulnerable with the sweeps going on.

Where we have relationships of trust, we have to have conversations about survivor sex, especially where it comes to getting in out of the cold.

This is all a giant, intermingled issue.
