- Camp Hope Closes
- June 9, 2023, the last resident of Camp Hope 2.0 left camp for housing. Camp Hope, the largest Homeless encampment in the State of Washington, with the assistance of the Department of Commerce Right Away of Way funding, is officially decommissioned and closed.



- Camp Hope was not closed by police sweeps, litigation, or political will. It was closed "in the spirit" of ROW funding, by providing housing, and better situations for the badged temporary residents of Camp Hope. It was closed in a trauma-informed, peer lead, intentional, collaborative, compassionate, and humane way.

The hope is vague, unsaid, and unformulated, but the need is great, and there is something in our hearts which troubles us/ that we have lost what was once so beautifully called "the commonweal."
- I suspect that if this open wound is to heal, it will have to heal like all wounds/ from the bottom, and that we shall have to begin at the beginning with the family and its obligations, with the village and its responsibilities, and with our universal and neglected duty to the earth.
